<b>5. Title, number of pages and language(s) of the notified document:</b> Draft Commission Regulation amending Annex III to Regulation (EC) No 1223/2009 of the European Parliament and of the Council on cosmetic products (4 pages + Annex 16 pages, in English).
<b>6. Description of content:</b> This draft Commission Regulation aims at authorising six hair dye substances for use in products intended to colour eyelashes and at regulating, in the context of the assessment strategy for hair dyes, ten newly assessed hair dye substances in Annex III to Regulation (EC) No 1223/2009. The proposed maximum authorised concentrations are based on the latest opinions of the Scientific Committee on Consumer Safety (SCCS) on these substances.
<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> Protection of human health and safety
<b>8.
