TO ALL MEMBERS OF CHEMEXCIL

SUBJECT: Nomination for Election to the Committee of Administration of Basic Chemicals, Cosmetics & Dyes Export Promotion Council (CHEMEXCIL), Mumbai for the year 2021-22 to 2022-23.

Dear Members.

As per the directions of Ministry of Commerce & Industry, Government of India, the undersigned has been nominated as a Returning Officer to conduct Election of Committee of Administration of Basic Chemicals, Cosmetics & Dyes Export Promotion Council (CHEMEXCIL) for the year 2021-22 to 2022-23 as per the Bye Laws of the Council.

1. PANEL-WISE VACANCY:

Panel-wise bifurcation of reservation category of CoA for the period 2021-22 & 2022-23 is as mentioned below:

Merchant Exporters Panel	General	01

2. ELIGIBILITY FOR ELECTION:

2.1 Right to Vote and Contest etc., confined to ordinary members:

Only an ordinary Member shall have the right to vote at or to offer self as a candidate at elections to various positions in the Council (as per para 4.1 of Bylaws of the Council)

2.2 Eligibility to Vote:

- A. An Ordinary Member shall have the right to vote at the Election of the Council's Committee of Administration (as per Article 4.1 of Bye Laws).
- B. Each ordinary member of the Council shall have one vote for every single representation/seat of the respective Panels as the Panel opted/registered with the Council from time to time.
- C. Tenure of the elected members of the Committee shall be for the period of two years. Such members shall be eligible to contest for election after a cooling period of one term after completion of every three consecutive terms for the members of CoA.

2.3 Eligibility for candidature:

- A. A candidate must be an Ordinary Member of the Council.
- B. A candidate contesting for the election to any position in the Council must satisfy the following conditions namely;
 - a) The firm or entity, must have to its credit, during immediately preceding one financial year the exports of the products falling under purview of the Council of not less than the amount mentioned below:

i. MSME: Rs. 25 Lakhs

ii. Others : Rs. 1 Crore (Merchant Exporter & LSM)

- b) Candidate contesting election, should have his/her name incorporated either in RCMC or Import-Export Code.
- c) For contesting the election for Merchant Exporter Panel the member company has to have <u>75% export of products coming</u> under the purview of the Council and should submit a Certificate from Auditor of the Company who signs the balance sheet.
- d) Candidate should represent the Industry which is member of the Council for the products coming under the purview of the Council. The Company engaged in 75% of total exports of the items coming under the purview of the Council and should comply with requirements of para 4.2(a) of Bylaws.
- e) Candidate applying for nomination for election should be allotted the Director Identification Number (DIN) under Section 154 of the Companies Act, 2013 s per para 4.2 (d) of the Bylaws of the Council.

2.4 Eligibility for Nomination:

- a) Nomination indicating the name of the authorized representative of the Member eligible for election to any Panel of the Committee of Administration shall be proposed by the member of the same panel.
- b) The nominee and proposer should be otherwise eligible to vote. The nominations shall conform to the proforma prescribed by the Election Authority.
- c) Any member under Denied Entity List maintained by DGFT will not be eligible to file nominations for election of Committee of Administration. Therefore, on the original Nomination form itself the member organization will also have to submit a declaration in writing signed by the Chairperson/Managing Director/ Director/Partner/Proprietor as the case may be that the name of the firm/company is not under Denied Entity List.

3. PROCEDURE FOR FILING & DEADLINE FOR SUBMISSION & WITHDRAWAL OF NOMINATION ETC.

A. A Nomination Form to be valid must be:

- a) Original Nomination Form enclosed with this Notice.
- b) Duly filled-in Nominations complete in all respects, along with the necessary declarations, duly signed, stamped and complying with the provisions of Election Rules herein before and as mentioned in this notice. The forms and notice will also be available on DGFT, Mumbai's website- http://dgftcom.nic.in/dgftmumbai and CHEMEXCIL's website https://chemexcil.in
- c) The sealed cover containing-
 - Filled in prescribed forms for the respective panels of the Committee of Administration duly proposed and signed by the nominee.
 - Turnover of Company duly certified by Chartered Accountant and
 - iii. Sealed envelope duly superscripted on top as "NOMINATION FOR CHEMEXCIL ELECTION" may be send to undersigned by hand-delivery or by Registered Post or Speed Post addressed to Shri M.K. Nikhare, Joint Director General of Foreign Trade & Election Authority of CHEMEXCIL, Nishtha Bhavan, 48 VithaldasThackersey Marg, Churchgate, Mumbai 400 020 as to reach on or before 2nd August, 2021 by 3.00 pm.
 - iv. Those nominations received after the due date and time shall not be considered. Those nominations which are not in accordance with this notice/specimen nomination form shall be treated as invalid.
 - A Nomination sent by telex/fax/telegram/e-mail to the Election Authority will be treated as invalid.
 - vi. Any Nomination forms submitted to any of the offices of CHEMEXCIL will not be considered for scrutiny and will be treated as invalid.
- B. The firm/company represented by the proposer & the firm/company represented by the Nominee should be member of the Council from the same Panel (Voter list). Nominee and the Proposer's name should not appear in Denied Entity List of Directorate general of Foreign Trade (Refer format given in Annexure A-2).

- C. In the event of the election, Authority having reasons to doubt the veracity of any of the particular/information contained in any Nomination form received by it, the Election Authority may call particulars/information from the Acting Executive Director of the Council. He/ She will also be at liberty to call for export performance of the member concerned as per the record of the Council from the Acting Executive Director.
- D. The names of the nominees panel-wise shall be entered in a register and after due scrutiny a list of valid nominations received will be prepared. Copies of such lists duly signed by the undersigned shall be sent to Head Office and all the Regional Offices of the Council. The same will be available on the website of DGFT, Mumbai and CHEMEXCIL's website. In case of the invalid nominations the undersigned shall cite the reason for rejecting the same.
- E. Nomination can be withdrawn by the candidate by a letter signed by him / her after aforesaid display of the list of valid nominations by the Election Authority. Original letter of withdrawal of nomination need to be submitted to the undersigned at Mumbai by post or through registered email with scan copy of withdrawal letter of company duly signed by candidates. Withdrawal of nomination will be allowed on or before 5th August, 2021 by 3.00 p.m.
- F. Such a withdrawal shall be final and no subsequent request, for revoking such withdrawal shall be entertained by the undersigned.
- G. The elections of the Committee of Administration of the Council shall be conducted by online electronic voting process; as per para 9.3(a) of the Bylaws of the Council. The user manual for the same will be available on DGFT, Mumbai's website http://dgftcom.nic.in/dgftmumbai and Council's website https://chemexcil.in
- H. For participating in the online electronic voting process a valid E-mail ID and Mobile number of the authorized representative is mandatory. Please check the voters list uploaded on DGFT, Mumbai website as well as CHEMEXCII, website for the e-mail id available in records with us.
- I. No further communication will be entertained in this regards for any modifications/ changes/updation in the records and therefore, details given as per the records of the Election Authority will be treated as final and correct.

Members may note that the said nomination notice and the forms are being printed and dispatched in hard copy by the Post for their convenience. However, Election Authority will not be responsible for the late receipt due to postal delay.
