#### **RESOLUTION N ° 2120**

Andean Technical Regulation on Microbiological Technical Specifications of Cosmetic products

#### THE GENERAL SECRETARIAT OF THE ANDEAN COMMUNITY:

**HAVING SEEN:** Letter b) of Article 30 of the Cartagena Agreement, the First Final Provision of Decision 833, Decisions 615, 827 and 851, and Resolutions No. 1418, No. 1482 and No. 2108; and,

WHEREAS: Decision 827 establishes the guidelines for the preparation, adoption and application of technical regulations and evaluation procedures of the conformity in the Member Countries of the Andean Community and at the community level;

That, the First Final Provision of Decision 833, on Harmonization of Legislations Regarding Cosmetic Products, it establishes that the General Secretariat, with recommendation of the Competent National Authorities of the Member Countries, adopt by resolution, the provisions that regulate the correct application of the aforementioned Decision;

That, Resolution No. 1418 and its amendment, Resolution No. 1482, establish the microbiological content limits of cosmetic products;

That, Resolution No. 2108, in its article 8, establishes that, for the specifications required microbiological, as established in literal l) of article 9 of the Decision 833, cosmetic products that are marketed in the Andean Subregion must comply with the Andean Technical Regulations approved by the General Secretariat of the Andean Community through Resolution; and

That, the Group of Government Experts for the Harmonization of Legislations
Sanitary (Human Health), in its meeting held on December 9, 2019,
recommended to the General Secretariat of the Andean Community the adoption through
Resolution of the Andean Technical Regulation on Technical Specifications
Microbiological of Cosmetic Products.

#### RESOLVES:

Approve the Andean Technical Regulation on Technical Specifications Microbiological of Cosmetic Products contained in this Resolution, corresponding to the Member Countries their due application.

## ANDEAN TECHNICAL REGULATION ON TECHNICAL SPECIFICATIONS MICROBIOLOGICS OF COSMETIC PRODUCTS

## CHAPTER I OF THE PURPOSE, FIELD OF APPLICATION AND DEFINITIONS

**Article 1.- Purpose.** The purpose of these Andean Technical Regulations is to establish the microbiological specifications that products must meet cosmetics that are marketed in the territories of the Member Countries, in order to protect human health or safety, as required in literal l) of article 9 of Decision 833 "Harmonization of Legislation in the field of cosmetic Products".

These Andean Technical Regulations also establish the specifications Physicochemical conditions of cosmetic products that are presumed to be free of microbiological contamination.

Article 2.- Field of application. These Andean Technical Regulations apply to cosmetic products identified in the indicative list of Decision 833, whose subheadings NANDINA are in Annex 1 of these regulations .

**Article 3.- Definitions.** For the purposes of these Andean Technical Regulations, The definitions established in Decision 833 and the regulations that the supplement or replace it.

## CHAPTER II OF MICROBIOLOGICAL TECHNICAL SPECIFICATIONS

**Article 4.- Microbiological specifications.** The cosmetic products that marketed in the Andean Subregion must meet the microbiological specifications indicated in the following table, according to their area of application and age:

Note. The values of the sample size to be examined for the respective tests will be determined by the internal rules and procedures of the Member Countries.

**Article 5.- Physical-chemical conditions.** Cosmetic products that comply with any of the physical-chemical conditions established in the following table, They will presume that they are free of microbiological contamination:

## CHAPTER III OF THE PROCEDURES FOR THE APPLICATION OF THE PRESENT ANDEAN TECHNICAL REGULATION

Article 6.- Administrative procedure. The application of this Regulation Andean Technician will be carried out according to the procedures for obtaining the Notification Sanitary Obligatory (NSO) of cosmetic products, their modification, renovation and recognition, established in Decision 833 and the Andean regulations that the supplement or replace it.

Article 7.- Conformity Assessment Procedure (PEC). In the app of this Andean Technical Regulation does not require a procedure conformity assessment to obtain the NSO required in article 6 of this Regulation. Notwithstanding this, the NSO Holder must maintain the certificates Analytical and test methods demonstrating compliance with specifications microbiological (Table N ° 1) or physicochemical (Table N ° 2) of this Regulation Andean Technician, as indicated in article 9 regarding control actions and health surveillance.

## CHAPTER IV CONTROL AND SURVEILLANCE

Article 8.- Inspection and / or supervision authority. The National Authority Competent of each Member Country, in exercise of the control and surveillance functions in the market, will be in charge of supervising compliance with the established in these Andean Technical Regulations.

**Article 9.- Inspection and / or supervision.** The Competent National Authority of each Member Country will carry out the supervision and control actions of compliance with this Andean Technical Regulations, as established in Chapter VII "Surveillance Sanitary "of Decision 833 and its amendments or the regulations that replace it.

In exercise of the functions of sanitary control and surveillance, the National Authority Competent may require the Head of the NSO, when they consider it, the presentation of the respective analytical certificate and the test methods necessary to demonstrate the compliance with the microbiological or physicochemical specifications established in these Andean Technical Regulations. Such methods must be standards-based

international, regional, national or of associations recognized internationally, as long as they are in force.

When the NSO Holder does not have the test method that demonstrates the compliance with the technical information of the cosmetic product required herein Andean Technical Regulations, the Competent National Authority may carry out or subcontract the respective analyzes, according to the methods available, whose result will be constituted as full evidence.

Article 10.- Sanctions regime. The Competent National Authority of each Country Member will proceed with the application of sanitary security measures and sanctions to which there is place for the breach of the present Technical Regulation Andean, as established in Chapter VII "On Health Surveillance" of the Decision 833 and its amendments or the regulations that replace it.

Article 11.- Entry into force. These Andean Technical Regulations will enter effective May 27, 2020.
