- Objective and rationale, including, where applicable, the nature of urgent problems: Protecting human life and health (For public health reasons, and given the threat of sanitation due to the persistence of increased notifications of accidents caused by poisonous animals, it is necessary to determine specific emergency health regulations, aimed at establishing the requirements Of local manufacture and import of antivenoms used in the country, through an emergency technical regulation that provides sanitary requirements without prejudice to their quality, safety and efficacy.
