In accordance with the provisions of article 9 of Law no. 239/2008 on transparency in the decision-making process, the Ministry of Agriculture, Regional Development and Environment initiates, starting with December 9, 2019, the elaboration of the draft Government Decision on the approval of the draft law on amending some legislative acts.

This draft law is developed pursuant to art. 34, paragraph (2) of Law no. 306/2018 on food safety.

Also, the project comes in the execution of position 181 of the National Action Plan for the implementation of the Association Agreement between the Republic of Moldova and the European Union in the period 2017–2019, approved by Government Decision no. 1472 of December 30, 2016.

The completions and amendments operated by this draft law concern the following normative acts:

Law no. 420/2006 on the activity of technical regulation;

Law no. 221/2007 regarding the sanitary-veterinary activity;

Law no. 10/2009 on state supervision of public health;

Law no. 50/2013 on official controls for verifying compliance with legislation on feed and food and animal health and welfare rules;

Law no. 279/2017 on informing the consumer about food products;

Law no. 296/2017 on the General Requirements for Food Hygiene.
