The event facilitated fruitful B2B interactions, strengthened buyer confidence in Indian sourcing, and opened new channels for trade and collaboration..

Similarly, our engagement at **Coating Vietnam 2025** was met with an enthusiastic response. The event provided an ideal platform to highlight India's growing presence in the coatings, paints, pigments, and allied sectors. With rising demand in Southeast Asia and beyond, such events are invaluable in enhancing the visibility of Indian exporters and exploring untapped markets.

I wish to thank all the member participants for their proactive engagement and commitment, and I encourage

others to take advantage of such platforms that CHEMEXCIL curates with care and strategic intent.

India-UK Free Trade Agreement Signed: A New Era for Chemical Exports

One of the most significant developments this year has been the successful **signing of the India-United Kingdom Free Trade Agreement (FTA)**. After multiple rounds of negotiations, this milestone agreement is poised to create immense opportunities for Indian businesses, particularly in the chemical sector.

The FTA is expected to reduce or eliminate tariffs on several key product categories, simplify customs procedures, and encourage mutual investments. Indian chemical exporters can now look forward to **enhanced market access to the UK**, particularly for products such as dyes and dye intermediates, agrochemicals, essential oils, and specialty chemicals.

I urge our members to undertake a strategic review of their export plans to the UK, evaluate the tariff advantages available under the FTA, and explore joint ventures or partnerships that could further enhance value-added exports. CHEMEXCIL will continue to engage with relevant stakeholders and share detailed guidance on the benefits and implementation of the agreement in due course.

CHEMEXCIL welcomes the move for the industry, the Department for Promotion of Industry and Internal Trade (DPIIT) has withdrawn the Quality Control Orders (QCOs) for Acetic Acid, Methanol, and Aniline, which were earlier notified under the BIS (Bureau of Indian Standards) regulatory framework.

The decision has been made in response to representations from the industry, including those submitted by CHEMEXCIL, highlighting the operational and cost burdens arising from mandatory QCO implementation for certain feedstock and bulk chemicals. This withdrawal is expected to:

- Provide relief to domestic manufacturers and traders,
- Lower costs related to certification and compliance,
- Streamline the import-export process for these specific chemicals, and
- Promote ease of doing business in alignment with national manufacturing goals.

We thank the Ministry for considering the industry's concerns and will continue to represent the sector's voice for pragmatic and growth-oriented regulatory reforms.

In line with the Government of India's vision for digital transformation and transparent policy-making, CHEMEXCIL has implemented **mandatory data submission through the CHEMINDIA Portal** (<https://chemindia.chemexcil.in/>).

This initiative is aimed at:

- Creating a comprehensive and real-time database of exporters,
- Facilitating targeted trade promotion measures,
- Enabling timely dissemination of export-related schemes and alerts, and
- Strengthening Council-Member coordination.

All member-exporters are **requested to log in and ensure completion of their data submission** at the earliest. Non-compliance may result in limited access to Council services, event participation, and certification facilities. We count on your cooperation in making this a robust and reliable platform for the Indian chemical export community.

As part of our annual pre-budget consultative process with the **Ministry of Finance**, CHEMEXCIL is in the process of drafting its **Pre-Budget Memorandum for 2026-27**.

This is an important opportunity for members to voice their suggestions regarding:

- Custom and excise duties,
- Export incentives and financial assistance schemes,
- GST-related challenges,
- Infrastructure and logistics support,

- Import policy barriers, and
- Any other fiscal or trade policy-related issues impacting the chemical sector.

We invite all members to send their inputs, backed with relevant data and justification, to enable us to incorporate them into the Council's consolidated representation. Your suggestions are essential in advocating effectively for an enabling business environment.

Friends, the global chemical industry stands at the cusp of a significant transformation, and India is well-positioned to play a pivotal role. CHEMEXCIL remains committed to supporting the sector through proactive engagement, policy advocacy, and international trade facilitation.

I thank each one of you for your continued support and trust in the Council's initiatives. Together, let us strive to expand India's chemical exports, deepen our global footprint, and build a future through innovation, sustainability, and resilience.

I take this opportunity to update you on some recent key developments, initiatives, and policy changes that are highly relevant for our sector.

CHEMEXCIL successfully coordinated the participation in two major international events this quarter – Chemspec Europe and Coating Vietnam 2025 – both of which provided significant visibility and business opportunities for Indian exporters. A major milestone on the policy front was the recent signing of the India–United Kingdom Free Trade Agreement (FTA). The agreement is expected to eliminate or reduce tariffs on several chemical product lines, improve regulatory transparency, and streamline customs procedures between the two nations.

For Indian chemical exporters, this translates into significant **export advantages** in a mature and quality-sensitive market such as the UK. The FTA opens avenues particularly for:

- Specialty chemicals,
- Dyes and dye intermediates,
- Agrochemicals,
- Cosmetics and personal care ingredients.

We urge members to study the FTA framework and understand product-specific benefits. CHEMEXCIL will soon be organizing informative sessions and sharing documentation to help members fully leverage this opportunity.

In a positive move for industry stakeholders, the Department for Promotion of Industry and Internal Trade (DPIIT) has announced the **withdrawal of the Quality Control Orders (QCOs) for Acetic Acid, Methanol, and Aniline.**

The Council had submitted industry feedback and represented the operational challenges faced by manufacturers and importers due to the implementation of QCOs on certain base chemicals. The Government's decision to withdraw these QCOs reflects a balanced regulatory approach and is expected to:

- Ease production bottlenecks,
- Lower compliance costs, and
- Facilitate smoother trade of industrial inputs.



We appreciate the Department's responsiveness to industry concerns and remain committed to working closely with all stakeholders for risk-based, pragmatic quality control regulations.

CHEMEXCIL has launched a renewed digital compliance initiative requiring **mandatory data submission** by all members on the **CHEMINDIA Portal** (<https://chemindia.chemexcil.in/>).

The objective is to create a unified exporter database that enables:

- More targeted trade promotion activities,
- Effective policy advocacy through real-time industry data,
- Faster delivery of Council services and certifications.

We urge all members to complete their submissions at the earliest. Non-compliance may impact access to RCMC renewals, participation in Council-led events, and other services. Your cooperation will ensure we have a reliable, structured data backbone to better serve the industry's needs.

As part of our annual engagement with the Ministry of Finance, CHEMEXCIL is preparing its **Pre-Budget Memorandum for 2026-27**. We invite valuable suggestions from members.

As moving forward in regulatory engagement, trade facilitation or innovation- we aim to enhance India's chemical exports by fostering a business-friendly environment, providing policy support, and facilitating ease of doing business for exporters.

Further, in alignment with the Government of India's long-term vision for a "Viksit Bharat" (Developed India) by 2047, CHEMEXCIL is proud to contribute to the roadmap through:

- Capacity-building initiatives,
- Internationalisation of Indian chemical brands,
- Encouraging sustainable and green chemistry practices,
- Skill development, digitalization, and compliance facilitation.

The chemical sector will play a pivotal role in achieving the Viksit Bharat goals across industrial self-reliance, innovation-led growth, employment generation, and global leadership in clean technologies. EU Customs Reform: What It Means for Indian Chemical Exporters

The European Union is undergoing its most ambitious customs reform in decades, and Indian chemical exporters must prepare to adapt. On 27th June 2025, the EU Customs Council reached a consensus on key aspects of its new customs framework, designed to make trade faster, safer, and more transparent across the EU bloc.

While the reform is aimed at easing trade and boosting digital integration, it also brings **stricter checks and higher compliance requirements**, especially for sensitive sectors like chemicals.

What Is Likely to Change in the EU Customs Framework?

The overhaul will **give customs authorities across the EU a more modern toolbox** to deal with trends such as huge increases in trade volumes, **especially in e-commerce**, a **fast-growing number of EU standards that must be checked at the border and shifting geopolitical realities and crises**.

Overall, this reform is expected to **give the EU the adequate means to stop noncompliant, dangerous or unsafe goods from entering the EU, collect customs duties more efficiently, and carry out adequate controls without putting excessive burden on authorities and traders**.

The agreement will allow interinstitutional negotiations with the European Parliament to begin on the core aspects of the reform, such as:

1. **Establishment of a new decentralised agency for customs – *the EU customs authority*** – which will support and help coordinate the risk management work of national customs authorities, and manage

the EU customs data hub

2. **Creation of a single EU-wide online environment – *the EU customs data hub*** – one central IT platform for interacting with customs and strengthening data integrity, traceability and customs controls
3. Introduction of enhanced **customs simplifications for the most trusted traders**, saving them time and money
4. Development of a **more modern approach to e-commerce**, adapted to the realities of a rapidly evolving landscape

The EU Customs Authority

The new framework **establishes a decentralised EU agency for customs** - the EU customs authority – which will coordinate governance of the EU customs union in a number of areas.

In particular, the EU customs authority will allow for **EU-level risk management supporting the work of national customs authorities, using the constantly updated import and export data in the new EU customs data hub**.

The EU customs authority will also coordinate EU-level crisis management in the area of customs.

The EU Customs Data Hub

The EU customs data hub will be a single online environment designed to collect and analyse data and deal with risk management.

In order to fulfil their customs obligations for trade consignments, **businesses will submit their customs information only once to this single portal**, rather than to individual customs authorities. **They will also be able to enter the same information to cover multiple consignments, saving them time and money**.

National customs authorities will gain a full overview of trade flows and supply chains. With the

support of the EU customs authority, Member States will therefore have access to the same real-time data and will be able to pool information to respond to risks more quickly, consistently and effectively.

Trust And Check Traders

The updated legislation creates a **new category of the most transparent businesses** – trust and check traders.

Under this scheme, **businesses that provide maximum information on their activities and that fulfil other strict criteria will benefit from simplified customs obligations.**

Additionally, in some cases, they will be able to **release their goods into circulation in the EU without any active customs intervention at all.**

Council Amendments

The Council's partial negotiating mandate makes a number of amendments to the original Commission proposal.

For example, **the text clarifies in more detail certain customs processes**, making them easier to implement by EU customs authorities and officials on the ground.

In relation to trusted traders, the Council's mandate **retains the existing authorised economic operators (AEO) scheme** already used by thousands of SMEs to simplify their customs obligations.

It provides for tailored measures to support SMEs' compliance with the new rules.

Finally, the text introduces the new concept of a **handling fee** to be collected by customs authorities on small consignments entering the EU through distance selling*.

**Distance selling refers to the sale of goods or services where the seller and buyer do not meet face-to-face during the transaction.*

Next Steps

Following the adoption of the Council's partial negotiating mandate, the presidency will start negotiations with the European Parliament on the file.

Discussions on certain aspects of the overall reform, such as in relation to the seat of the EU Customs Authority, on a simplified tariff system and the exact design of the handling fee, will take place at a later stage.

What does this mean for the Indian Chemical Industry?

Let us first look at CHEMEXCIL'S exports to the EU –

Given the scale of India's chemical exports to the EU, it is crucial that exporters understand and prepare for how the reforms could impact documentation, packaging, compliance, and logistics.

The EU's new Customs reform includes several targeted measures affecting chemical imports:

- **Customs Data Hub & EU Customs Authority**

A unified digital platform will integrate EU-wide customs data, including links to chemical registries. Customs authorities will be able to verify REACH registration numbers and import authorisations directly at the border, enhancing compliance and safety checks while reducing duplication.

- **Enhanced Surveillance of Industrial Chemicals**

The EU has begun rigorous tracking of key industrial chemicals, such as ethylene copolymers, high-nitrogen urea, and ammonium sulphate, through its Customs Surveillance System. This three-year monitoring effort is intended to detect import surges that could harm EU producers (policy.trade.ec.europa.eu).

- **Strengthened REACH Import Controls**

Under the EU's Chemicals Strategy, customs and the European Chemicals Agency (ECHA) are working closely to ensure imported chemicals meet REACH registration, authorisation, and labelling standards. A project running into 2025 intensifies checks on chemical imports for compliance (trade.gov).

- **Digital Labelling & Safety Regulations (CLP Reform)**

Simpler, standardized labelling and packaging rules, finalized in December 2024, facilitate smoother chemical movements across the bloc by making hazard communication more transparent and traceable (single-market-economy.ec.europa.eu).

Practical Impact on Indian Chemical Exporters

1. Stricter REACH Compliance at Customs

- Indian exporters must **register their chemicals under REACH** (Registration, Evaluation, Authorisation and Restriction of Chemicals) **before exporting** to the EU.
- The new EU Customs platform will **automatically verify REACH compliance** at the border, so any gaps in registration or missing data may lead to:
 - ❑ Delays in clearance
 - ❑ Rejection of consignments
 - ❑ Fines or legal consequences for the EU importer

Action: Partner with EU-based importers/Only Representatives (ORs)* to ensure all chemicals are properly registered under REACH.

**In the context of the EU's REACH regulation, an Only Representative (OR) is a legal entity established in the European Union that a non-EU manufacturer or*

formulator appoints to fulfill the obligations of importers under REACH.

2. CLP Labelling & Packaging Compliance

- The revised Classification, Labelling and Packaging (CLP) regulations now require:
 - ❑ Digital labelling compatibility
 - ❑ Clear hazard communication
 - ❑ Up-to-date Safety Data Sheets (SDS)

Action: Ensure **GHS-compliant labels**, multilingual safety sheets, and digital formats are prepared in advance.

3. Surveillance of High-Risk Chemicals

- Certain chemicals are under special surveillance. (ethylene copolymers, ammonium sulphate, nitrogen-based compounds)
- Sudden spikes in exports of these chemicals can attract anti-dumping investigations or safeguard duties.

Action: Monitor volume trends, diversify product mix, and prepare for **voluntary disclosure of pricing and source data** if asked.

4. Trusted Trader & Authorised Economic Operator (AEO) Schemes

- EU's reforms promote digital customs clearance and low-risk **fast lanes** for compliant traders.
- Indian firms that can demonstrate **consistent** compliance history, transparent documentation, and secure supply chains may benefit from quicker entry.

Action: Apply for **AEO status in India**, and align documentation with EU customs requirements to be considered a low-risk exporter.

5. Alignment with EU Green & Sustainability Standards

- Chemicals with hazardous profiles or high environmental impact may face additional scrutiny or phased restrictions under the EU's Green Deal and Chemicals Strategy for Sustainability.

Action: Start shifting towards **greener formulations**, **circular economy practices**, and **eco-certifications** to remain competitive in the long run.

Key Risks

Risk	Impact
REACH non-compliance	Detention of goods at EU ports
Incorrect labelling or SDS	Fines or rejection by customs authorities
Price undercutting on sensitive goods	Anti-dumping investigations
No traceability	Ineligibility for customs fast-track

Strategic Recommendations

- Audit all EU-bound products for REACH and CLP compliance.
- Partner with Only Representatives (ORs) in the EU to handle registration and documentation.
- Go digital – align your documentation systems

- Apply for AEO status and prepare your firm for “trusted trader” eligibility.
- Invest in greener alternatives to stay ahead of evolving EU regulations.

Conclusion: Preparedness Is the Key

The EU’s customs reform is not just about digitization, it’s about building a smarter, safer, and more sustainable trade environment. For Indian chemical exporters, this is a wake-up call to **strengthen compliance, adopt digital systems, and build long-term competitiveness.**

Those who act early and invest in transparency and traceability stand to benefit the most with **faster clearances, preferential treatment, and a stronger position** in one of the world’s most demanding markets

Future of India's Chemical Industry: A Roadmap for MSME-Led Export Growth and Indigenous Innovation

India's chemical industry is entering a pivotal growth phase. As the sixth-largest producer globally, India is well-positioned to benefit from shifting global supply chains and the China+1 strategy. The country's strengths in specialty chemicals, agrochemicals, and pigments can be leveraged to enhance its export presence. Promoting "Product India" as a brand of quality, safety, and competitiveness should be a national priority.

This requires aggressive participation in global trade platforms, certification facilitation, and marketing support.

MSMEs are the backbone of India's chemical industry but face challenges in scaling globally due to limited access to compliance tools, finance, and certification. To make them export-ready, the government should set up **Export Facilitation Centres** in key clusters, provide support for certifications like REACH and ISO, and offer incentives for green technologies. Simplifying trade procedures and improving export credit access will further strengthen MSME competitiveness.

A **Mutual Recognition Agreement (MRA)** should be signed by BIS with leading international quality certification agencies, such as REACH in Europe and equivalent agencies in the US and other FTA partner countries. This will ensure a level playing field for Indian exporters, especially MSMEs, when accessing markets that mandate exclusive certification protocols. MRAs will significantly reduce compliance duplication, lower export costs, and improve market access.

To enable smoother international market entry, **market facilitation** must be strengthened through India's embassies, and there should be close cooperation between **line ministries**, the **Ministry of Commerce**, **Ministry of MSME**, and in the case of chemicals, the **Ministry of Chemicals and Fertilizers**. Furthermore, enabling **MSME supply to PSUs** can significantly enhance their credibility and confidence, serving as a strong reference for building trust with overseas buyers.

MSMEs often lack the resources for R&D due to high costs and long timelines. Government initiatives like **Innovation Clusters** and **Design Clinics** can offer grants and guidance to support low-risk, high-impact innovation. Additionally, most MSMEs avoid patenting due to limited awareness and financial barriers. Setting up **Patent Support Cells**, subsidizing filing costs, and promoting patented MSME products in procurement and exports will boost indigenous innovation and strengthen India's global technological position.

To drive transformation, India must build a strong ecosystem through **Integrated Chemical Parks** with CETPs, warehousing, testing labs, and export logistics. These hubs can foster innovation, compliance, and efficiency. Digital trade platforms and targeted skill development in regulation, safety, and exports are also essential. Simultaneously, import substitution should be prioritized by promoting domestic production of key raw materials through focused schemes, technology transfer, and R&D support-enhancing self-reliance, value addition, and job creation.

Quality Control Orders (QCOs) introduced by BIS are key to standardizing quality, ensuring safety, and strengthening India's global brand. For MSMEs, QCOs present both a challenge and an opportunity. With support for testing, awareness, and compliance costs, MSMEs can meet QCO norms and access wider markets. QCOs also help restrict substandard imports, boosting domestic manufacturing.

The **Anusandhan National Research Foundation (ANRF)** should prioritize funding for import substitution R&D, especially in areas with limited domestic availability, to reduce import dependence and boost local manufacturing. It should also provide targeted support to MSMEs through dedicated R&D funding and technical assistance to promote indigenous innovation, enhance competitiveness, and strengthen their integration into value chains.

A joint effort by the government, industry, and institutions is key to achieving sustainable, inclusive growth in the sector.





Seminars & Workshops

1. Sensitization-cum-Onboarding Camp on ChemIndia Portal

The four-day **Sensitization-cum-Onboarding Camp** on the **ChemIndia Portal** was conducted by the Department of Chemicals & Petrochemicals at **CIPET-IPT, Vatva, Ahmedabad** from **1st to 4th July, 2025**.

The primary aim of this initiative was to **educate and onboard exporters and industry stakeholders** to the **ChemIndia Portal** - a flagship platform by Ministry of Chemicals & Fertilizers for data submission for the chemical and petrochemical sectors.

The program was inaugurated on 1st July with Opening Remarks by CIPET, Mr. Ankit Patel, Regional Chairman - Northern Region, CHEMEXCIL delivered the Keynote. The officer from DCPC did the a live demonstration of the ChemIndia portal functionality, followed by Interactive Q&A.

From **2nd to 4th July**, the full day sessions were dedicated to **on-the-spot onboarding** of companies by guiding and assisting Companies in registering and submitting their data on the portal.

Over **70 member companies** from **Ahmedabad, Vadodara, and other industrial cluster in Gujarat** actively participated in the camp (From 1st to 4th July). Representatives (Companies' business owners, Directors, marketing heads, export managers, and technical executives, operators) from leading chemical, dyes, Dye intermediates, Agro chemicals and pigment, participated in this Camp.



More than **35 companies** completed their registration on the **ChemIndia Portal**, while others

successfully submitted their export-related data during on board session.

The camp facilitated **real-time onboarding** and enabled participants to gain a clear understanding of



the data submission process and overall functionality of the ChemIndia portal. The participants successfully completed their registration on the ChemIndia portal.

2. **Workshop on CHEMINDIA Portal Mandatory data Submission-Demo and Interaction with Department officials on 7th July 2025 in Mumbai.**

Ministry of Chemicals and Fertilizers in February mandated that all registered chemical and petrochemical industries/units in India (with a few exemptions) submit data on the portal, the apex body for chemical exports said.

CHEMEXCIL (Basic Chemicals, Cosmetics and Dyes Export Promotion Council) added that non-compliance with the mandatory data submission requirements is a violation under the Collection of Statistics Act, 2008, as amended by the Jan Vishwas (Amendment of Provisions) Act, 2023.

To educate and ensure timely and accurate data submission from the chemical industry, the council organised a day-long workshop in Mumbai on July 7, 2025.

"The workshop aimed to create awareness and prepared industry for timely and accurate data submission on the portal," The workshop witnessed participation of 115 delegates from the industry, comprising exporters, manufacturers, and industry stakeholders who were keen to understand the operational aspects and compliance requirements of the portal.

Mr. Raghuveer Kini, Director General, CHEMEXCIL, said the move would help streamline regulatory data and enhance transparency across the chemical sector.



2. Virtual Interactive Session to Address Issues Related to Data Submission on ChemIndia Portal on 5th June, 2025

CHEMEXCIL, in collaboration with the Department of Chemicals & Petrochemicals (DCPC), Government of India, organized a virtual interaction session on 5th June 2025. The virtual workshop addressed the practical challenges exporters face in submitting mandatory data on the ChemIndia Portal. The session served as a direct platform for industry representatives to share feedback with government officials. The interactive nature and detailed discussions helped 90 participants gain clarity on submission protocols and expectations.

- **Registration strategies and timelines**, including updates under the latest REACH revisions
- **Role of Only Representatives (ORs)** and supply chain communication
- **Data sharing, consortia participation, and cost management**
- **Consequences of non-compliance**, including product bans and market denial

Experts also addressed participant queries during a live Q&A, covering practical challenges in dossier preparation and substance identification.

The webinar concluded with an emphasis on early planning, strategic partnerships, and staying updated on evolving EU chemical regulations. Participants expressed strong appreciation for the practical insights shared and indicated improved readiness to navigate the REACH registration process.

The Meeting was chaired by Thiru R.Ramani, General Manager, District Industries Centre, Vellore. The agenda of the meeting was on Draft District Export Action Plan (DEAP). The meeting was attended by DGFT, CHEMEXCIL, Leather Export Promotion Council, APEDA.



Physical Meetings attended by Council's Officials:

1. The 19th meeting of the Customs Consultative Group (CCG) was held on July 2-3, 2025, in Bengaluru under the chairmanship of Shri Surjit Bhujabal, Member (Customs), Central Board of Indirect Taxes and Customs (CBIC), Ministry of Finance.

CCG is the apex national platform for deliberation on all matters concerning customs clearance of merchandise in international trade. The Group comprises prominent representatives from industry chambers such as CII, FICCI, ASSOCHAM, FIEO, MAIT, NASSCOM, PHDCCI, STPI, CHEMEXCIL and 35 Export Promotion Councils and two associations representing the air freight sector were also inducted into the CCG, the meeting also had the representative from associations of logistics partners including customs brokers, freight forwarders, liquid bulk cargo handlers, port operators, and banks

The meeting witnessed active participation from senior officials of CBIC and its field formations, along with representatives from RBI, DGFT, Bureau of Indian Standards (BIS), Department for Promotion of Industry and Internal Trade (DPIIT), Department of Posts, Ministry of Shipping, Airport Authority of India, Central Pollution Control Board, Animal Quarantine Department, Central Drugs Standard Control Organization (CDSCO), and the Food Safety and Standards Authority of India (FSSAI).

A total of 181 agenda points were sponsored by stakeholders and deliberated upon during the two-day event. During interaction, Shri Surjit Bhujabal emphasised the critical role played by CCG in enhancing trade facilitation and fostering an enabling environment for ease of doing business. He noted that the CCG has proven to be a model of responsive governance, bringing about both policy-level and operational changes. He cited the previous CCG meeting held in November 2024, during which 116 out of 136 agenda points were successfully addressed through policy circulars, operational instructions, and the development of new subsystems under ICEGATE, the Customs clearance gateway.

Dear Members,

This has reference to our circular no. EPC:LIC:IND:REA:CHE:POR:DCPC-2025-26:MISC-2 dated 27th May 2025 regarding the mandatory data submission on the ChemIndia Webportal. The copy of the same can be viewed on <https://chemexcil.in/circulars/v.imp---notice-for-chemical-and-petrochemical-industries:-data-submission-on-chemindia-webportal/6435/418d5ed205e4e2d7c3c58c1f7ead4206.html>

In continuation of the same, CHEMEXCIL wish to **reiterate the importance of compliance with the Gazette Notification issued by the Ministry of Chemicals and Fertilizers, dated 27th February 2024**. All registered chemical and petrochemical industries/units in India, except those dealing in specific exempted categories, are required to submit data on the ChemIndia Webportal (<https://chemindia.chemicals.gov.in/>) as per our previous circular.

Merchant exporters along with the following category of chemicals are exempted from this mandatory data submission.

1. Paints
2. Cosmetic Products
3. Fireworks
4. Petroleum Products (e.g., Lubricants)
5. Pharmaceutical Products
6. Fertilizers
7. Metals in Pure Form

Serious Implications of Non-Compliance

Non-compliance with the mandatory data submission requirements is a serious violation under the Collection of Statistics Act, 2008, as amended by the Jan Vishwas (Amendment of Provisions) Act, 2023, effective from December 10, 2024, **failure to produce, submit** documents, information or neglect/refusal to provide the required information **may result in a flat penalty ranging from Rs. 5,000 to Rs. 100,000 per day of non-compliance.** *(Copy of relevant acts are enclosed for your information.)*

Handholding and Support

- To ensure compliance and address queries, CHEMEXCIL has collaborated with Department of Chemicals and Petrochemicals concerned officials and recently organized a virtual session with them (Copy of the PPT is enclosed for your kind perusal).
- **An additional awareness session (Physical and Virtual) will be conducted in the coming days to assist our members in understanding and fulfilling these requirements.**

3. Estimated financial impact on your operations/exports (e.g., increased raw material costs, production losses).
4. Any challenges in sourcing alternative suppliers (e.g., from other African or non-African countries).
5. Are you exploring alternative sources for shea nuts or butter? If yes, specify countries or regions.
6. Feasibility of substituting shea with other ingredients.
7. Feedback from international buyers regarding supply chain disruptions.



8. Any recommendations to ensure supply continuity.
9. Any other relevant point

Sub: Update on EU CLP Regulation – Harmonised Classification and Labelling of Chemical Substances (Regulation (EU) 2025/1222)

Dear Members,

This is to inform you that the European Commission has issued Commission Delegated Regulation (EU) 2025/1222 of 2 April 2025, which amends Regulation (EC) No 1272/2008 (CLP Regulation) concerning the harmonised classification, labelling, and packaging of certain substances.

This amendment updates Annex VI, Part 3, Table 3 of the CLP Regulation.

New substances have been added and existing entries are updated based on scientific evaluations by the Committee for Risk Assessment (RAC) of ECHA.

The substances affected include a broad range such as:

- Industrial chemicals (e.g., ozone, dinitrogen oxide, vinylidene chloride)
- Agrochemicals/biocides (e.g., captan, folpet, dinotefuran, pethoxamid)
- Pigments and dyes (e.g., Pigment Red 53:1)
- Botanical extracts (e.g., Chrysanthemum cinerariaefolium)
- Others with hazard classes like carcinogenicity, reproductive toxicity, acute toxicity, STOT, aquatic toxicity, etc.

This regulation has entered into force from 20 days after its publication in the Official Journal (i.e., 20th June 2025).

Exporters to EU region must ensure compliance with updated labelling by 1 Feb 2027. However, suppliers may begin adopting the new classifications immediately to align with EU safety and environmental norms.

Member exporters are advised to review the updated classifications for any substances they manufacture/export to the EU and ensure that all relevant SDSs, labels, and packaging are compliant with the updated requirements by the due date.

Early voluntary compliance is encouraged to support supply chain readiness and maintain market access in the EU.

- Members should have completed 12 months of Membership of the Council.
- Reimbursement of airfare to the companies having nil exports/ start-ups/ new exporters may be allowed up to 10% of the total number of participants, subject to the following conditions:
 - The amount of airfare reimbursable will be 50% of the economy fare, subject to market-wise ceilings prescribed in the Scheme guidelines,
 - The exporter has been active in the domestic market and has at least annual turnover of Rs. 50.00 lakh in the preceding financial year.
 - Regularly filing Export returns with the Council
 - Airfare will be permissible only to the regular Director / Partner/Proprietor or a regular officer of the company in a senior managerial position.
 - Air fare Claim forms duly filled in and complete in all respects must be submitted to the council within 45 days (counted from last date of the event, If not submitted, airfare will not be reimbursed to those Member companies).
 - The Airfare Reimbursement will be done after the finalization of Accounts in the Ministry & Subject to receipt of funds from the Department.

General



- A company having DEL STATUS (as per DGFT) is not eligible for participation under the MAI scheme.
- Once the event is over exhibitors must submit the outcome report within 5 days. format will be provided by Chemexcil on-site or by email.

Dear Members,

This has reference to our earlier circular no EPC:PW:LIC:QCO:2024-25: 79 dated 7th August 2024 on Gazette Notification for extension of enforcement date of QCOs of 3 Chemicals viz. (i) Acetic Acid (ii) Methanol (iii) Aniline. As per the same the deadline for the extension for the QCO for (i) Acetic Acid (ii) Methanol (iii) Aniline **till 3rd August, 2025** (Ref. <https://chemexcil.in/circulars/imp---gazette-notification-for-extension-of-enforcement-date-of-qcos-of-3-chemicals--viz--i--acetic-acid--ii--methanol--iii--aniline/6232/7cee70d65058e4315a24691cff1fe909.html>)

Since these chemicals are critical inputs for various sectors such as, dyes and intermediates pharmaceuticals, textiles, paints, adhesives, and agrochemicals, etc. India sources significant quantities of acetic acid and aniline from China and the US, while methanol is primarily imported from Gulf countries.

In view of above department has withdrawn the QCOs that mandates compliance for both domestic and imported goods vide Gazette notification no. CG-DL-E-23072025-264914 dated 23rd July 2025.

Now these chemicals will no longer require compliance with compulsory BIS standards. The detailed notification is enclosed for your reference.

Greetings from CHEMEXCIL!

As you might have aware that the India-United Kingdom Free Trade Agreement (India-UK FTA) has been officially signed on 24th July 2025 in London by Hon'ble Prime Minister Shri Narendra Modi and UK Prime Minister Mr. Keir Starmer.

This is a landmark agreement, an important step forward in strengthening bilateral trade and investment between the two nations and it presents a major opportunity for India's Chemical sector along with all other sectors.

The key highlights relevant to the Chemical Sector is Indian Chemical exporters **will get zero-duty market access** for more than 1000 Chemical tariff lines, covering a wide range of chemical products.

- India's Chemical Exports to the UK stand at USD 570.32 million during FY 2024-25 which accounts for approximately 2% of India's total global chemical exports.
- The UK's total chemical imports from the world is USD 35.11 billion of which India currently captures only USD 570.32 million, indicating significant untapped potential.
- This FTA is expected to boost India's chemical exports to the UK by 30%–40%, during coming financial year i.e., FY 2025–26.
- Indian Chemical Exporters will have a competitive advantage through duty-free tariff access, they can explore the long-term partnerships, joint ventures, and technology exchange. It is a big boost for MSMEs and exporters of niche chemical products.
- Moreover, the UK REACH deadline is extended
