

## **STEPS FOR ONLINE STALL BOOKING OF CHINA INTERDYE 2019**

**Step 1:-** Click on [https://chemexcil.in/events/ChinaInterdye2019/stall\\_registration.php](https://chemexcil.in/events/ChinaInterdye2019/stall_registration.php)  
Floor plan will be displayed after clicking this link.

**OR**

Go to our website <https://chemexcil.in> . Click on the banner named as “China Interdye 2019”. It will redirect you to the stall booking page wherein the floor plan will be displayed.

**Step 2:-** Click on the desired stall no on the floor plan. After clicking it, the stall reservation form will be displayed.

**Step 3:-** Please enter the first 3 characters of your company name which is member of CHEMEXCIL. A list of companies that are member of CHEMEXCIL will be displayed. Choose your company name amongst the list of companies displayed and click on the radio button.  
**Please note only members of CHEMEXCIL can book the stall.**

**Step 4:-** Fill in the other details on the reservation page. Please note that all fields are mandatory.

**Step 5:-** Enter the stall no reserved by your company in the CAPINDIA Exhibition 2019.

**Step 6:-** Please ensure that your correct email id is entered as the stall reservation email will be sent on this email id only.

**Step 7:-** Click on register. Your stall will get reserved subject to receipt of payment.

**Step 8:-** You will get an email acknowledgement towards the blocking of your stall on the email id mentioned in the above form.

**Step 9:-** After clicking on Register, the payment page will open. If you have made the payment, then you have to enter the RTGS / NEFT Details and click on submit. You may also add the Demand Draft number and other details. The payment details mentioned by you will be checked by the Council’s accounts team and then the stall will get confirmed.

**Step 10:-** In case, you have not done the payment, then you may choose the option to “pay later”. You can do the payment by NEFT / RTGS/ DD on or before **13<sup>TH</sup> Feb 2019**. The RTGS / NEFT payment should get credited in Council’s bank account within 2 days from the date of booking the stall i.e. on or before 13th Feb 2019. The actual Demand Draft should reach Council’s office on or before 14th Feb 2019.
