

Declaration cum Indemnity on loss of Original **Registration cum Membership Certificate (RCMC)** by the Company/Firm on Stamp paper of Rs. 200/- duly notarized by notary public.

We (i)..... (ii)..... and (iii)..... carrying on business in partnership at ....., in the firm name and style of Messrs ..... registered under the Indian Partnership Act 1930 (Hereinafter referred to as the Firm ) do hereby jointly and severally declare and say as under:-

1. We declare, and confirm as under:-

(a). that we are the partners of the Firm;

(b). that on our Application and at our request **Basic Chemicals, Cosmetics & Dyes Export Promotion Council** a Company registered under the Companies Act,1956, having its registered office at Jhansi Castle, 4th Floor, 7 Cooperage Road, Mumbai 400 039 (hereinafter referred to as Chemexcil) had issued Registration cum Membership Certificate (Hereinafter referred to as the said RCMC ) bearing No. .... dated .....

(c). that the said RCMC was in our possession till ..... Recently it is noticed that the said RCMC is not traceable and inspite of our best efforts and diligent search we have not been able to trace the same. We confirm that at present it has been lost;

(d). that on making inquiry with the Chemexcil for issuing duplicate of the said RCMC, Chemexcil requested and required us to give Declaration cum Indemnity on stamp paper of Rs. 200 which we have agree to do so:-

2. We declare, confirm covenant and undertake as under:-

(a). that the said RCMC was in our possession till ..... Recently it is noticed that the said RCMC is not traceable and inspite of our best efforts and diligent search we have not been able to trace the same and it has been lost; 3

(b). that the said RCMC is not confiscated by any office of the Government Department under the provisions of any of the law, statue, ordinance etc. for the time being in force and particularly applicable to the business carried on by the Firm, due to the offence, if any, committed by us/the Firm;

(c). That there are no suits or litigations or proceedings pending in any Court of Law against the Firm / us under the Income Tax Act, Central Excises Act, Sales tax Act, or under any other law for the time being in force, by which the said RCMC is attached or Confiscated by the order of the Competent Court or the Firm is restrained or prevented by the Hon'ble Court and/or concerned authorities / Department from having and/or using the said RCMC for the firm s benefit;

(d). that we and the firm have paid the respective Tax, duties levied under the law for the time being in force and there are no arrears for the same pending against us/the firm;

(e). that we shall indemnify and keep Chemexcil fully and effectually indemnified from time to time and at all times hereafter of from and against all actions, suits, proceedings, claim, demand of any nature whatsoever made against Chemexcil for issuing duplicate of the said RCMC and costs, charges, Losses and expenses which Chemexcil may have to incur or suffer, to protect the Chemexcil for issuing Duplicate RCMC to the Firm. We undertake and covenant to reimburse such expenses to Chemexcil on being called upon to do so;

3. We make this declaration cum indemnity solemnly, sincerely jointly severally and consciously believing that what is stated in the foregoing declarations are true to our own knowledge and belief and relying upon the strength and the representations thereof Chemexcil is going to issue Duplicate RCMC in favour of the Firm.
