TO ALL MEMBERS OF THE COUNCIL:

Re.: Nomination for Election to the Committee of Administration of Basic Chemicals, Cosmetics & Dyes Export Promotion Council, Mumbai for the period 2024-26.

Dear Members,

As per the direction of Ministry of Commerce & Industry, Government of India, the undersigned has been appointed as a Returning Officer to conduct Election of Committee of Administration of Basic Chemicals, Cosmetics & Dyes Export Promotion Council (Chemexcil) for the period 2024-26 as per the Bye Laws of the Council.

Chemexcil is holding election for 14 seats under different categories.

1. PANEL-WISE VACANCIES:

2. ELIGIBILITY FOR ELECTIONS:

2.1 Right to Vote and Contest etc. confined to ordinary members

Only an ordinary member shall have the right to offer its representative as a candidate at elections to various positions in the Council (as per Para 4.1 of Bye Laws).

2.2 Eligibility to Vote

- a) An Ordinary members shall have the right to vote at the election of the Council's Committee of Administration (as per Article 4.1 of Bye Laws).
- b) Associate members having been completed 3 continuous years, and not fulfilling the eligibility criteria for Ordinary Member, however, have exports in his/her credit in any of the preceding three years, shall also have the right to vote.
- c) Each Ordinary Member of the Council shall have one vote for every single representation/seat for the respective Panels and Categories as per the Panel opted/registered with the Council from time to time.
- d) Tenure of elected members of the Committee shall be for the period of two years. Such members shall be eligible to contest for election after a cooling period of one term.

2.3 Eligibility for Candidature

A candidate for election to any position (except Chairperson and Vice- Chairperson) in the Council must satisfy the following conditions:

- a) He/ She or the entity represented by him/ her must have to his/ her or its credit during the two financial years immediately preceding the election the average exports of the products of not less than the amount mentioned below:
 - i. **Micro, Small, Medium Enterprises (MSMEs):** Rs.50 Lakh - Rs.2.5 Crore (Micro Enterprises- Rs. 50 Lakhs, Small Enterprises -Rs. 1 crore and Medium Enterprises- Rs. 2.5 crore)
 - ii. **Others:** Above Rs.2.5 Crore
 - iii. Three Seats are reserved for categories of women entrepreneurs (already filled), startups, young entrepreneurs (less than 40 years of age as on 31st March 2024); and North Eastern/Hill Regions to ensure their suitable representation in the Committee.
- b) where a person is contesting for election as Regional Chairperson, he/ she or the entity represented by him/her must have minimum average exports of the product to the tune of Rs. 2.5 crores to his/ her or its credit during the two financial years immediately preceding.

2.4 The eligibility for Nomination

- a) Nomination indicating the name of the authorized representative of the Member eligible for election to any Panel of the Committee of Administration shall be proposed by members of the same Panel.
- b) The nominee and proposer should be otherwise eligible to vote. The nominations shall conform to the proforma prescribed by the Election Authority.
- c) Any voter / member under Denied Entity List maintained by DGFT will not be eligible to file nominations for election of Committee of Administration. Therefore, on the original Nomination form itself the Member organization will also have to submit a declaration in writing signed by the Chairperson / Managing Director / Director / Partner / Proprietor as the case may be that the name of the firm / company is not under Denied Entity List.

3. **PROCEDURE FOR FILING & DEADLINE FOR SUBMISSION & WITHDRAWAL OF NOMINATION ETC.**

A. A Nomination Form to be valid, must be:

(a) Original Nomination Form enclosed with this Notice.

(b) Duly filled-in Nominations complete in all respects, along with the necessary declarations, duly signed, stamped and complying with the provisions of Election Rules herein before and as mentioned in this notice. The forms and notice will also be available on the DGFT, Mumbai's website- <https://www.dgft.gov.in> and CHEMEXCIL's website <https://chemexcil.in>.

(c) The sealed cover containing -

- i. Filled in prescribed forms for the respective panels of the Committee of Administration duly proposed and signed by the nominee
- ii. Turnover of Company duly certified by Chartered Accountant and
- iii. Sealed envelope duly superscripted on the top as "**NOMINATION FOR CHEMEXCIL ELECTION**" may be sent to undersigned by **hand-delivery or by Registered Post or by Speed Post** addressed to Jt. Director General of Foreign Trade & Election Authority for CHEMEXCIL, Nishtha Bhavan, 48, Vithaldas Thackersey Marg, Churchgate, Mumbai 400 020 so as to reach on or before **August 26, 2024 by 3.00 pm.**
- iv. Those nomination received after the due date and time shall not be considered. Those nominations which are not in accordance with this notice/specimen nomination form shall be treated as invalid.
- v. A Nomination sent by telex/fax/telegram/e-mail to the Election Authority will be treated as invalid.
- vi. Any Nomination forms submitted to any of the offices of CHEMEXCIL will not be considered for scrutiny and will be treated as invalid.

B. The firm / company represented by the proposer & the firm / company represented by the Nominee should be member of the Council from the same Panel (Voter list) . Nominee and the Proposer's name should not appear in **Denied Entity List of Directorate General of Foreign Trade** (Refer format given in Annexure A-2).

C. In the event of the election, the Election Authority having reasons to doubt the veracity of any of the particular/information contained in any Nomination form received by it, the Election Authority may call particulars/information from the Director General of the Council. He / She will also be at liberty to call for export performance of the member concerned as per the record of the Council from the Director General.

D. The names of the nominees panel-wise shall be entered in a register and after due scrutiny a list of valid nominations received will be prepared. Copies of such lists duly signed by the undersigned shall be sent to Head Office and all the Regional Offices of the Council. The same will be available on the website of DGFT, Mumbai and CHEMEXCIL's website. In case of the invalid nominations the undersigned shall cite the reason for rejecting the same.

E. Nomination can be withdrawn by the candidate by a letter signed by him / her after aforesaid display of the list of valid nominations by the Election Authority. Original letter of withdrawal of nominations needs to be submitted to the undersigned at Mumbai by post or through registered email with scan copy of withdrawal letter of company duly

signed by candidates. Withdrawal of nomination will be allowed on or before **August 29, 2024 by 3.00 pm.**

- F. Such a withdrawal shall be final and no subsequent request, for revoking such withdrawal shall be entertained by the undersigned.
- G. The elections to the Committee of Administration of the Council shall be conducted by online electronic voting process; as per para 9.1 of the Bye Laws of the Council. The user manual for the same will be available on DGFT, Mumbai's website <https://www.dgft.gov.in> and CHEMEXCIL's website <https://chemexcil.in>.
- H. For participating in the online electronic voting process a valid E-mail ID and mobile number of the authorized representative is mandatory. Please check the voters list uploaded on DGFT, Mumbai website as well as CHEMEXCIL website for the e-mail id available in records with us.
- I. No further communication will be entertained in this regard for any modifications / changes / up-dation in the records and therefore, details given as per the records of the Election Authority will be treated as final and correct.
