The total export performance of the items covered by the Council for the period April 2019 to March, 2020 was USD 18.41 billion as against USD 19.14 billion of the corresponding period of last year.

We are glad to say that India and Vietnam have traditionally been close with friendly ties which encompass the entire range of economic, social and cultural relations that are emerging as the mainstay of the bilateral relationship. Bilateral trade between India and Vietnam has seen steady growth over the years. For India, Vietnam is the 18<sup>th</sup> largest trading partner globally and within ASEAN, the 4<sup>th</sup> largest trading partner after Singapore, Indonesia and Malaysia. For Vietnam, India is the 7th largest trading partner.

India's export of Chemicals (under our purview) to Vietnam in 2019-20 was US\$247.69 million registering a growth of 7.73% over the previous year export of US\$229.91 million. The Key items exported from India to Vietnam in respect of chemicals are insecticides, fungicides, disinfectants, carbon black, reactive blacks, organic chemicals etc.

Chemexcil has always endeavored to augment the marketing efforts for their member exporters and assist them in expanding their international business. Even during the COVID-19 pandemic and growing global economic uncertainties, Chemexcil is striving to guide the member exporters on how to overcome the challenges in this pandemic situation as well.

#### **FACT SHEET- VIETNAM**







#### **Background:-**

The conquest of Vietnam by France began in 1858 and was completed by 1884. It became part of French Indochina in 1887. Vietnam declared independence after World War II, but France continued to rule until its 1954 defeat by communist forces under Ho Chi MINH. Under the Geneva Accords of 1954, Vietnam was divided into the communist North and anti-communist South. US economic and military aid to South Vietnam grew through the 1960s in an attempt to bolster the government, but US armed forces were withdrawn following a cease-fire agreement in 1973. Two years later, North Vietnamese forces overran the South reuniting the country under communist rule. Despite the return of peace, for over a decade the country experienced little economic growth because of conservative leadership policies, the persecution and mass exodus of individuals - many of them successful South Vietnamese merchants - and growing international isolation. However, since the enactment of Vietnam's "doi moi" (renovation) policy in 1986, Vietnamese authorities have committed to increased economic liberalization and enacted structural reforms needed to modernize the economy and to produce more competitive, export-driven industries. The communist leaders maintain tight control on political expression but have demonstrated some modest steps toward better protection of human rights. The country continues to experience small-scale protests, the vast majority connected to either land-use issues, calls for increased political space, or the lack of equitable mechanisms for resolving disputes. The small-scale protests in the urban areas are often organized by human rights activists, but many occur in rural areas and involve various ethnic minorities such as the Montagnards of the Central Highlands, Hmong in the Northwest Highlands, and the Khmer Krom in the southern delta region.

### National Flag:-



The **Vietnam flag** was officially adopted on November 30, 1955. The gold five-pointed star symbolizes the five groups of workers in the building of socialism (intellectuals, peasants, soldiers, workers and youths), while the red symbolizes bloodshed, and the revolutionary struggle.

It is the fourth constitution adopted by the Vietnamese government since the political reunification of the country in 1976.

#### **ECONOMY - OVERVIEW**

Vietnam is a densely populated developing country that has been transitioning since 1986 from the rigidities of a centrally planned, highly agrarian economy to a more industrial and market based economy, and it has raised incomes substantially. Vietnam exceeded its 2017 GDP growth target of 6.7% with growth of 6.8%, primarily due to unexpected increases in domestic demand, and strong manufacturing exports.

Vietnam has a young population, stable political system, commitment to sustainable growth, relatively low inflation, stable currency, strong FDI inflows, and strong manufacturing sector. In addition, the country is committed to continuing its global economic integration. Vietnam joined the WTO in January 2007 and concluded several free trade agreements in 2015-16, including the EU-Vietnam Free Trade Agreement (which the EU has not yet ratified), the Korean Free Trade Agreement, and the Eurasian Economic Union Free Trade Agreement. In 2017, Vietnam successfully chaired the Asia-Pacific Economic Cooperation (APEC) Conference with its key priorities including inclusive growth, innovation, strengthening small and medium enterprises, food security, and climate change. Seeking to diversify its opportunities, Vietnam also signed the Comprehensive and Progressive Agreement for the Transpacific Partnership in 2018 and continued to pursue the Regional Comprehensive Economic Partnership.

#### BILATERAL RELATIONS BETWEEN INDIA AND VIETNAM

#### **Development of bilateral and commercial ties:**

India granted the "Most Favoured Nation" status to Vietnam in 1975 and both nations signed a bilateral trade agreement in 1978 and the Bilateral Investment Promotion and Protection Agreement (BIPPA) on March 8, 1997. The Indo-Vietnam Joint Business Council has worked to promote trade and investment since 1993. In 2003, both nations promulgated a Joint Declaration on Comprehensive Cooperation when the General Secretary of the Communist Party of Vietnam Nông Đức Manh visited India and both nations are negotiating a free trade agreement. In 2007, a fresh joint declaration was issued during the state visit of the Prime Minister of Vietnam Nguyễn Tấn Dũng. Bilateral trade has increased rapidly since the liberalisation of the economies of both Vietnam and India. India is the 13th-largest exporter to Vietnam, with exports that have grown steadily from \$11.5 million in 1985-86 to \$395.68 million by 2003. Vietnam's exports to India rose to \$180 million, including agricultural products, handicrafts, textiles, electronics and other goods. Between 2001 and 2006, the volume of bilateral trade expanded at 20-30% per annum to reach US\$1 billion by 2006. Continuing the rapid pace of growth, bilateral trade is expected to rise to \$2 billion by 2008, 2 years ahead of the official target. India and Vietnam have also expanded cooperation in information technology, education and collaboration of the respective national space programmes. Direct air links and lax visa regulations have been established to bolster tourism.

In 2010, as the ASEAN-India free trade agreement came into effect, bilateral trade exploded to US\$3.917 billion by the end of 2012, with Vietnam exporting \$1.7 billion to India in 2012, an increase of 56.5% from 2011. As of 2015 bilateral trade stands at US\$7 billion & both nations have agreed on a target of US\$20 billion by 2020.

The PRC has complained about Indian cooperation for the exploration for oil in Vietnamese waters, especially in light of the disputed political status of the Spratly Islands, and other nearby island chains, which India currently recognises as part of Vietnam.

#### **Strategic cooperation:**

India and Vietnam are both members of the Mekong–Ganga Cooperation, created to develop and enhance close ties between India and nations of Southeast Asia. Vietnam has supported India's bid to become a permanent member of the U.N. Security Council and join the Asia-Pacific Economic Cooperation (APEC).[17] In the 2003 joint declaration, India and Vietnam envisaged creating an "Arc of Advantage and Prosperity" in Southeast Asia; to this end, Vietnam has backed increasing the significance of the relationship between India and the Association of Southeast Asian Nations (ASEAN) and its negotiation of an Indo-ASEAN free trade agreement. India and Vietnam have also built strategic partnerships, including extensive cooperation on developing nuclear power, enhancing regional security and fighting terrorism, transnational crime and drug trafficking.


