## **FACT SHEET- ARGENTINA**



### **ABOUT:**

Argentina is a country located mostly in the southern half of South America. Sharing the bulk of the Southern Cone with Chile to the west, the country is also bordered by Bolivia and Paraguay to the north, Brazil to the northeast, Uruguay and the South Atlantic Ocean to the east, and the Drake Passage to the south. With a mainland area of 2,780,400 km<sup>2</sup> (1,073,500 sq mi),[B] Argentina is the eighth-largest country in the world, the fourth largest in the Americas, the second largest in South America after Brazil, and the largest Spanish-speaking nation by area. The sovereign state is subdivided into twenty-three provinces and one autonomous city, Buenos Aires, which is the federal capital of the nation as decided by Congress. The provinces and the capital have their own constitutions, but exist under a federal system. Argentina claims sovereignty over part of Antarctica, the Falkland Islands (Spanish: Islas Malvinas), and South Georgia and the South Sandwich Islands

### **NATIONAL FLAG:**



The flag of Argentina is a triband, composed of three equally wide horizontal bands coloured light blue and white. There are multiple interpretations on the reasons for those colors. The flag was created by Manuel Belgrano, in line with the creation of the Cockade of Argentina, and was first raised at the city of Rosario on February 27, 1812, during the Argentine War of Independence. The National Flag Memorial was later built on the site. The First Triumvirate did not approve the use of the flag, but the Asamblea del Año XIII allowed the use of the flag as a war flag. It was the Congress of Tucumán which finally designated it as the national flag, in 1816. A yellow Sun of May was added to the center in 1818, which according to anarchist Diego Abad de Santillán, the sun represents the Incan god of the sun Inti., but its true symbolism is a matter of debate between vexillologists.

## **BILATERAL RELATIONS BETWEEN INDIA AND ARGENTINA**

India and Argentina are not historically, culturally and linguistically connected but when we trace back India's relation with Argentina it comes out to be very old. It started when Rabindranath Tagore visited Argentina in 1924. During pre-independence India, World War II brought serious food shortages to India, with the prospect of a deadly famine looming in 1946. Argentina responding to an Indian appeal, played a critical role in exporting corn and wheat during this challenging period. In early 20th century, first Indians to arrive in Argentina were Sikhs from the Indian state of Punjab who came to Argentina to work on a British-built railroad. Argentina seemed the most promising of South American nations, and so they stayed, eventually concentrating in the north, which reminded them of the scrappy mountains and plains of Punjab.

Last year, India and Argentina celebrated 70 years of bilateral relations. Both countries relations are an example of a strong tie in political, economic, agriculture, scientific, nuclear energy and technological cooperation including Antarctic research and cultural cooperation.

According to Daniel Chuburu, ambassador of Argentina to India said "India is a very important partner for us. Both food and energy security, people to people as well as tourism are important for further deepening the relationship. As far as food security is concerned, we are keen on establishing a relationship with India."

### **Political Relations**

Political relations between India and Argentina started with Trade Commission in Buenos Aires in 1943 which was later converted into one of the first Embassies in South America in 1949. Ties with Argentina energised when by President Cristina Fernandez's visit to India in 2009, the first in 15 years. Recently, India-Argentina relations were elevated to the level of Strategic Partnership during the State Visit to India of President of Argentina in February 2019. Multi-faceted relations between the two countries have strengthened over the years and encompass political, economic, cultural and scientific & technological cooperation.

### **ABOUT**

Brazil officially the Federative Republic of Brazil is the largest country in both South America and Latin America. At 8.5 million square kilometers (3.2 million square miles) and with over 211 million people, Brazil is the world's fifth-largest country by area and the sixth most populous. Its capital is Brasília, and its most populous city is São Paulo. The federation is composed of the union of the 26 states and the Federal District. It is the largest country to have Portuguese as an official language and the only one in the Americas; it is also one of the most multicultural and ethnically diverse nations, due to over a century of mass immigration from around the world; as well as the most populous Roman Catholic-majority country.

Bounded by the Atlantic Ocean on the east, Brazil has a coastline of 7,491 kilometers (4,655 mi).[16] It borders all other countries in South America except Ecuador and Chile and covers 47.3% of the continent's land area.[17] Its Amazon basin includes a vast tropical forest, home to diverse wildlife, a variety of ecological systems, and extensive natural resources spanning numerous protected habitats.[16] This unique environmental heritage makes Brazil one of 17 mega diverse countries, and is the subject of significant global interest, as environmental degradation through processes like deforestation has direct impacts on global issues like climate change and biodiversity loss.

### **National Flag.**



Green with a large yellow diamond in the center bearing a blue celestial globe with 27 white five-pointed stars; the globe has a white equatorial band with the motto ORDEM E PROGRESSO (Order and Progress); the current flag was inspired by the banner of the former Empire of Brazil (1822-1889); on the imperial flag, the green represented the House of Braganza of Pedro I, the first Emperor of Brazil, while the yellow stood for the Habsburg Family of his wife; on the modern flag the green represents the forests of the country and the yellow rhombus its mineral wealth (the diamond shape roughly mirrors that of the country); the blue circle and stars, which replaced the coat of arms of the original flag, depict the sky over Rio de Janeiro on the morning of 15

November 1889 – the day the Republic of Brazil was declared; the number of stars has changed with the creation of new states and has risen from an original 21 to the current 27 (one for each state and the Federal District)

**BILATERAL RELATIONS BETWEEN INDIA AND BRAZIL**

India and Brazil share a very close and multifaceted relationship at bilateral level as well as in plurilateral fora such as BRICS, BASIC, G-20, G-4, IBSA, International Solar Alliance, Biofuture Platform and in the larger multilateral bodies such as the UN, WTO, UNESCO and WIPO. The bilateral strategic partnership, which has opened a new phase for India-Brazil relations in 2006, is based on a common global vision, shared democratic values, and a commitment to foster economic growth with social inclusion for the welfare of the people of both countries.

**Political Relations**

India's relationship with Brazil continued to grow over the past decades with various high-level exchanges and got further intensified in 2019 and early 2020 with the back to back VVIP visits. President Jair Bolsonaro congratulated Prime Minister Narendra Modi on the latter's re-election in May 2019. PM Modi met President Bolsonaro on the sidelines of the G20 Summit in Osaka on 29 June 2019. Key issues of bilateral importance were discussed during the meetings, opening up opportunities on both sides to take the strategic partnership forward. PM Modi attended the XI BRICS Summit in Brasilia on 13-14 November 2019 and held a bilateral meeting with President Bolsonaro on the sidelines of the Summit on 13 November 2019. At the invitation of PM Modi, President Bolsonaro paid a State Visit to India from 25-27 January 2020. He was the Chief Guest at India's Republic Day Parade on 26 January 2020 and was accompanied by a high-level delegation which included eight Ministers, four Members of Parliament, senior officials of the Brazilian Government and members of business community. Brazil, for the first time in its history, signed 15 MoUs and agreements with a country during a Presidential Visit. With these MoUs and agreements, India and Brazil decided to widen cooperation in the areas of oil and natural gas, bioenergy, trade and investment, mutual legal assistance in criminal matters, early childhood, health and medicine, traditional systems of medicine and homeopathy, social security, cyber security, science and technology, geology and mineral resources, animal husbandry and dairying, and culture. The two countries also adopted the Action Plan to Strengthen the Strategic Partnership.

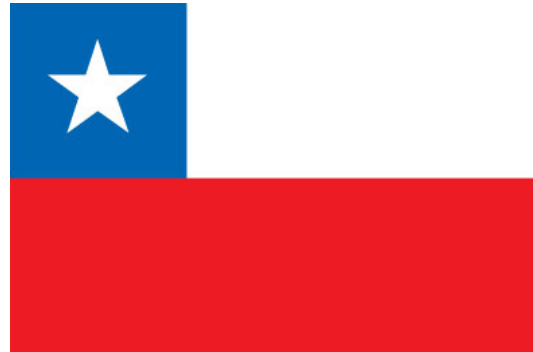

### ABOUT

Chile is a long, narrow country stretching along South America's western edge, with more than 6,000km of Pacific Ocean coastline. Santiago, its capital, sits in a valley surrounded by the Andes and Chilean Coast Range mountains. The city's palm-lined Plaza de Armas contains the neoclassical cathedral and the National History Museum. The massive Parque Metropolitano offers swimming pools, a botanical garden and zoo.

### NATIONAL FLAG



The flag of Chile consists of two equal horizontal bands of white and red, with a blue square the same height as the white band in the canton, which bears a white five-pointed star in the center. It was adopted on 18 October 1817. The Chilean flag is also known in Spanish as La Estrella Solitaria (The Lone Star).

It has a 3:2 ratio between length and width; it is divided horizontally into two bands of equal size (the lower being red). The upper area is divided once: in a square (blue), with a single centered white star; and rectangle (white), whose lengths are in proportion 1:2.

The star may represent a guide to progress and honor while other interpretations refer to its reference to an independent state; blue symbolizes the sky and the Pacific Ocean, white is for the snow-covered Andes, and red stands for the blood spilled to achieve independence.

According to the epic poem La Araucana, the colors were derived from those from the flag flown by the Mapuche during the Arauco War. "Flag Day" is held each year on the ninth of July to commemorate the 77 soldiers who died in the 1882 Battle of La Concepción.

Chile was the first country in South America to sign a trade agreement with India, in 1956. A Framework Agreement was signed on January 20, 2005 to promote further Economic Cooperation between India and Chile. The agreement proposed a Preferential Trade Agreement (PTA) between the respective countries, which after several rounds of negotiations was finalized during the talks held at New Delhi in November 2005. The PTA came into force with effect from 17 August 2007 in Chile and in India on 11 September 2007.

In 2016, both countries signed an agreement to expand the India- Chile Preferential Trade Agreement (PTA), marking a 10-fold jump in the number of products to be traded on concessional duty rates. India's bilateral trade with Chile stood at \$2.6 billion with exports at \$0.68 billion and imports at \$1.96 billion respectively in FY16.

### **Political Relations:**

India-Chile relations are characterized by warmth, friendship and a commonality of views on a wide range of issues. Chile shares India's concerns over the threat of international terrorism and has regularly condemned the acts of cross-border terrorism that India has suffered. Both countries cooperate extensively in multilateral fora and share similar views on climate change/renewable energy issues and on expansion and reforms of the UNSC. Chile articulated its support for India's claim to a permanent seat in the UNSC in a Joint Statement issued at the conclusion of the official visit of Chile's Foreign Minister to India in April 2003, and has consistently reiterated this support since. It also signed the International Solar Alliance Framework Agreement in November 2017.

The Defence Wing in the Embassy of India, Santiago, was established in July 2006. In 2009, India and Chile celebrated 60 years of the establishment of diplomatic relations which coincided with the visit to India by the President of Chile, H.E. Dr. Michelle Bachelet Jeria. This was in reciprocation of then Hon'ble President of India, Smt. Pratibha Devisingh Patil's visit to Chile in 2008. The Sixth Round of India-Chile Foreign Office Consultations was held in New Delhi on 31 October, 2014. Hon'ble President Ram Nath Kovind visited Chile (30 March to 1 April 2019) which also marked the 70th Anniversary of establishment of India-Chile diplomatic relations. President Pinera has also expressed a keen desire to visit India. The first India-Chile Joint Commission Meeting was held virtually on 16 October 2020, co-chaired by India's External Affairs Minister and Chile's Foreign Minister.

India and Chile have signed Agreements/MoUs covering various fields of cooperation such as Sports, S&T, Antarctica, Defence, Air Services, Agriculture, New and Renewable Energy, Education, Outer Space, Geology and Mineral Resources, and Gainful employment of spouses and eligible dependents of diplomatic personnel. On 6 September 2016, an Agreement on the expansion of the India-Chile Preferential Trade Agreement (PTA) was signed in New Delhi which increased the scope of the agreement from about 474 tariff lines to 2829 tariff lines. Further expansion of the PTA is under discussion. During MoS (VK)'s visit to Chile in May 2018, an MoU was also signed on the establishment of a high-level Joint Commission between India and Chile. During visit of Hon'ble President on 1 April 2019, agreements for cultural exchange and cooperation in mining sectors were renewed and an agreement was signed on cooperation in disability sector. The Double Taxation Avoidance Agreement between India and Chile was signed on 9 March 2020.

### ABOUT

Colombia, officially the Republic of Colombia, is a country in South America with territories in North America. Colombia is bounded on the north by the Caribbean Sea, the northwest by Panama, the south by Ecuador and Peru, the east by Venezuela, the southeast by Brazil, and the west by the Pacific Ocean. It comprises 32 departments and the Capital District of Bogotá, the country's largest city.

With over 50 million inhabitants, Colombia is one of the most ethnically and linguistically diverse countries in the world, with its rich cultural heritage reflecting influences by various Amerindian civilizations, European settlement, forced African labor, and immigration from Europe and the greater Middle East. Urban centers are concentrated in the Andean highlands and the Caribbean coast.

Colombia has been inhabited by various indigenous peoples since at least 12,000 BCE, including the Muisca, Quimbaya, and the Tairona. The Spanish landed first in La Guajira in 1499 and by the mid-16th century colonized parts of the region, establishing the New Kingdom of Granada, with Santafé de Bogotá as its capital. Independence from the Spanish Empire was achieved in 1810, with what is now Colombia emerging as the United Provinces of New Granada.

**Yellow:** Represents the riches of the country, the wealth of the Colombian soil, the gold, sovereignty, harmony, justice and agriculture, as well as the Sun, and the source of light.

**Blue:** represents the sky above, the seas on Colombia's shores, the rivers that run through..

**Red:** represents the blood spilled for Colombia's independence and also the effort of Colombian people, their determination and perseverance. It represents that although Colombia's people have had to struggle they have thrived.

Although, the flag has other representations such as blue for loyalty and vigilance, red for victory of battles for Colombian independence, and finally yellow for sovereignty and justice.

## **BILATERAL RELATIONS BETWEEN INDIA AND COLOMBIA:**

Colombia and India established diplomatic relations on 19 January 1959 and completed 60 years in 2019. In March 1972, Colombia opened its Embassy in New Delhi. India, opened its Embassy in Colombia the following year. Over the years, the relationship between the two countries have strengthened and diversified in all areas of mutual interest encompassing political, commercial and cultural fields.

Bilateral trade between India and Colombia had been steadily growing until 2014 and reached approximately US\$ 4 billion (largely as a result of oil imports by India from Colombia). However, following the global slump in oil prices, that affected Colombian exports of oil, bilateral trade registered a decline in 2015 and 2016. From 2017, bilateral trade has once again started growing. In calendar year 2018, bilateral trade was approximately US\$ 2.1 billion. India's imports from Colombia include mineral fuels, precious stones (pearls), aluminum, zinc, wood (teak), plastic etc. India's exports to Colombia include vehicles (motorcycles etc.), cotton, pharmaceuticals, iron & steel products, chemicals, etc. 2015 onwards, the balance of payments has remained in favour of India.

### **Political relations**

India and Colombia enjoy friendly and cordial bilateral relations. Both countries collaborate in various multilateral fora. Foreign Office Consultations Mechanism was established in 1995. The last Foreign Office Consultations took place in March 2017 in New Delhi.

President Ram Nath Kovind sent a message of felicitation to President Ivan Duque, after the latter was sworn in as the new President of Colombia on 7 August 2018. Then External Affairs Minister had also sent a message of felicitation to Mr. Carlos Holmes Trujillo, the then Foreign Minister of Colombia. She later met him on the sidelines of the UN General Assembly in September 2018. Gen. V.K. Singh, MOS (EA), met Colombian FM in October 2018 during his visit to Colombia. These were the highest level interaction with the new Government of Colombia, which came to power in August 2018. During the UN General Assembly in 2019, a pull aside meeting was held between our Prime Minister and Colombian President Ivan Duque.

## **FACT SHEET- MEXICO**



### **ABOUT**

Mexico officially the United Mexican States; EUM, is a country in the southern portion of North America. It is bordered to the north by the United States; to the south and west by the Pacific Ocean; to the southeast by Guatemala, Belize, and the Caribbean Sea; and to the east by the Gulf of Mexico. Mexico covers 1,972,550 square kilometers (761,610 sq mi), making it the world's 13th-largest country by area; with approximately 126,014,024 inhabitants, it is 10th-most-populous country and has the most Spanish-speakers. Mexico is organized as a federation comprising 31 states and Mexico City, its capital and largest metropolis. Other major urban areas include Guadalajara, Monterrey, Puebla, Toluca, Tijuana, Ciudad Juárez, and León.

Pre-Columbian Mexico traces its origins to 8,000 BC and is identified as one of six cradles of civilization; it was home to many advanced Mesoamerican civilizations, most notably the Maya and the Aztecs. In 1521, the Spanish Empire conquered and colonized the region from its base in Mexico City, establishing the colony of New Spain. The Catholic Church played an important role in spreading Christianity and the Spanish language, while also preserving some indigenous cultures. Native populations were heavily exploited to mine rich deposits of precious metals, which contributed to Spain's status as a major world power for the next three centuries. Over time, a distinct Mexican identity formed, based on a fusion of indigenous and Europeans customs; this contributed to the successful Mexican War of Independence against Spain in 1821.

### **NATIONAL FLAG**



The flag of Mexico is a vertical tricolor of green, white, and red with the national coat of arms charged in the center of the white stripe. While the meaning of the colors has changed over time, these three colors were adopted by Mexico following independence from Spain during the country's War of Independence, and subsequent First Mexican Empire. The form of the coat of arms was most recently revised in 1968, but the overall design has been used since 1821, when the First National Flag was created.

Red, white, and green are the colors of the national army in Mexico. The central emblem is the Mexican coat of arms, based on the Aztec symbol for Tenochtitlan (now Mexico City), the center of the Aztec empire. It recalls the legend of an eagle sitting on a cactus while devouring a serpent that signaled to the Aztecs where to found their city, Tenochtitlan. A ribbon in the national colors is at the bottom of the coat of arms. Throughout history, the flag has changed several times, as the design of the coat of arms and the length-width ratios of the flag have been modified. However, the coat of arms has had the same features throughout: an eagle, holding a serpent in its talon, is perched on top of a prickly pear cactus; the cactus is situated on a rock that rises above a lake.

**BILATERAL RELATIONS BETWEEN INDIA AND MEXICO:**

India and Mexico have warm and cordial bilateral relations as well as contacts going back to centuries and commonality of views on a wide range of issues. Both countries have striking similarities in geo-climatic conditions, biodiversity, physiognomy and people, cultural and family values. India and Mexico are both heirs of great civilizations and have European connections from their colonial era.

Bilateral trade between India and Mexico has shown rapid growth in recent years. In 2018-19, the bilateral trade grew at the rate of 22% to US\$ 9.42 billion from US\$ 7.71 billion in the same period in 2017-18. The two-way trade in 2018 was US\$ 10.155 billion, comprising of exports worth US\$ 5.231 billion and imports valued at US\$ 4.923 billion. The trade balance is in favour of India. Amongst the Mexico's global trade partners, India's rank rose from 10 to 9 in a span of one year. In 2018, Mexico has emerged as the largest trade partner of India in Latin America and the Caribbean region and the second in all of Americas after the USA. In 2018, India-Mexico bilateral trade has also surpassed the bilateral trade with Brazil.

India's exports comprise mainly of vehicles and auto parts, organic chemicals, aluminum products, electrical machinery & electronic equipment, products of iron and steel and gems, ceramic products and jewelry. Our imports include crude oil (75% of the imports), electrical goods and machinery, electronic equipment, vehicles and auto parts. India is also the third largest buyer of Mexico's crude oil. Potential areas for bilateral trade include software and IT, pharmaceuticals, chemicals, engineering goods, renewable energy, biotechnology, auto parts and minerals.

In order to facilitate bilateral trade, an India-Mexico Business Chamber (IMBC) was launched in May 2019. A major factor in the increasing trade between India and Mexico is the increasing number of visits to Mexico by businessmen from India. Around 300 businessmen visit Mexico every year from India and there is regular participation in large trade shows like InterModa (Fashion sector), Expo Ferreterra and CIHAC (Construction sector), and Plastimagen (plastics sector).

Investments from India in Mexico are estimated to be worth US\$ 3 billion. Most of the leading Indian companies in IT/software (such as TCS, Infosys, Wipro, NIIT, BirlaSoft, HCL, Aptech, Hexaware, and Patni.) and pharmaceutical sectors (including Hetero labs, Sun Pharma, Dr.Reddy's Laboratories, and Torrent Pharmaceuticals) have set up joint ventures in Mexico taking advantage of its strategic location, large market and investment friendly policies. Major investments in the steel and mining sector have also been made by the Arcelor Mittal Group. In 2008, JK Tyres of India bought Mexican tyre company Tornel and in 2009 Uflex set up a greenfield packaging products project with an eye on the US market. Samvardhana Motherson Group has set up 15 plants all over northern and central Mexico employing over 23000 Mexicans. Pharma company Zydus commenced operations in 2013. In September 2014, Lupin acquired a pharma company in Mexico. In May 2014, Tech Mahindra established an office in Mexico City to provide IT & other related services and in 2018, added 2nd campus in Aguascalientes. Currently, over 180 Indian companies have presence in Mexico. Parle started its first manufacturing facility in western hemisphere in Mexico in 2018 and also became first Indian food processing company to start its business in Mexico.

Seventeen major Mexican companies have presence in India. This includes leading Mexican companies like Nemak (auto), Metalsa, Mexichem, Tremec (auto), Great Foods & Beverages, RuhrPumpen (pumps), Cinopolis and Kidzania. Mexican IT company Softtek became the first Latin American company to have a presence in India as service provider.

Recently Bimbo Group made investment acquiring a major stake in Harvest Gold brand. Cinopolis has opened over 350 screens all over India penetrating into tier 2 cities as well. In total, the investment is estimated to be around US\$ 1 billion.

The flagship conclave of the Ministry – India Latin America and Caribbean (LAC) Conclave was held for the first time outside India on 28-29 November, 2016. It was inaugurated by General (Retd.) V.K. Singh, Minister of State (MOS) for External Affairs in Guadalajara, Mexico. Confederation of Indian Industry (CII) organized the event, in partnership with the United Nations Economic Commission for Latin America and the Caribbean (UN ECLAC) and the Government of Jalisco, Mexico. The conclave, which included plenary session, business-to-business meetings, networking lunches, panel discussions and breakout sessions saw the participation of over three hundred delegates from various Latin American Countries as well as a large number of Indian delegates.

There exists a Bilateral High Level Group (BHLG) co-chaired by the Commerce Secretary and his Mexican counterpart which looks into ways to promote trade and investments with a focus on areas such as tourism, chemicals, infrastructure, pharmaceuticals, textiles and bio-fuels through relevant working groups. The 4th meeting of the BHLG was held in Mexico City in July 2016, during which the two countries decided to sign MOUs for investment promotion and for SMEs in the near future. India and Mexico signed an Agreement on Mutual Administrative Assistance in Customs Matters on 15 October 2012. In July 2013, Mexico supported India's proposal at the Codex Alimentarius Commission to create a Committee on Spices and Culinary Herbs.
