TRADE NOTICE NO.: 02/2016-17 - SERVICE TAX

Sub: Re-energizing/operationalising e-helpline in Service Tax, Mumbai Zone - reg.

Attention of all Trade and Industry is invited to Trade Notice No.03/E-HELPLINE/CCO MUMBAI ZONE-I/2012 dated 28th September 2012 wherein it was informed that an "E-Helpline" facility at the Zonal level has been launched on the website www.servicetaxmumbai.gov.in for clarifying the doubts of trade and industry. With a view to make the Taxpayer Services more user friendly, a twitter handle stmumbai_tweet has also been created for further facilitation of the trade and industry in this regard.

- 2. While reiterating the availability of the e-helpline and the twitter handle, it is informed that the said Trade Notice has been amended to the extent that help in assessment matters would be restricted to procedural issues only. Help on other substantive legal issues in relation to assessment viz. classification and value determination will not fall under the purview of the e-helpline and twitter handle, particularly as these facilities are for addressing local issues and problems. The help with regard to resolving procedural delays and help in addressing the systems related problems remains unchanged.
- 3. With the view to make the e-helpline and the twitter handle effective platforms, it has been decided not to insist on PAN, Registration number, etc. from the applicants for seeking clarifications via these media.
- 4. All the trade associations are requested to make use of this e-helpline and the twitter handle and bring the contents of this Trade Notice to the attention of their members in particular and the trade in general.
