### Dear Sir,

It gives us immense pleasure to inform you that Council is organizing trade delegation (Buyer Seller Meet) in **Taipei, Taiwan** on 16th Sep, 2019 & in **Tokyo, Japan** on 18th Sep, 2019.

This event will be organized under Market Access Initiative (MAI) scheme of Ministry of Commerce & Industry, Government of India.

The objective of this event to interact directly with the Chemical and cosmetics buyers in Japan and Taiwan to enhance India's Chemical exports in this region.

### JAPAN CHEMICAL INDUSTRY.

The Japanese chemical industry is the country's second largest manufacturing industry after transportation machinery. As the strength of Japan's economy lies in its industry, one can say that the chemical industry is the backbone of Japan's economy. The Japanese chemical industry is dominated by a group of major corporations. Most of them are highly diversified and sport a large number of subsidiaries. The Japanese Chemical Industry in a Broader Sense encompasses Plastics Products (3.8 percent of Japan's total manufacturing value output), Rubber Products (1.1 percent), and the Chemical Industry in a Narrower Sense (9.4 percent). The latter can be divided into five general areas: Fertilizers, which accounted for 1.2 percent of the Chemical Industry in the Narrower Sense in 2013, Inorganic Chemicals (7 percent), Organic Chemicals (42 percent), and End Products (49.9 percent). Organic Chemicals include Basic Petrochemicals (9.4 percent of the total), Aliphatic Intermediates (4.8 percent), Cyclic Intermediates, Dyestuffs and Pigments (7.5 percent), Plastics (12.7 percent), Synthetic Rubbers (2 percent), and other organic chemicals (5.5 percent).



End Products include Oil and Fats, Soap, Detergents and Surfactants (3.9 percent of the total), Paints (3.5 percent), Drugs & Medicines (27.8 percent), Agricultural Chemicals (1.1 percent), Cosmetics and Toothpast (4.8 percent), Gelatins & Adhesives (1.1 percent), Photo-sensitized materials (1.1 percent), and other chemical end products (6.5 percent).

## INDIA Taiwan BILATERAL RELATIONS

Taiwan holds the 7th position in the chemical sales world ranking according to Cefic's recent 2018 annual review. Taiwan's chemical output, roughly at \$150 billion around 2013–2014, has been accounting for almost 1/3 gross production value of Taiwan's manufacturing. Petrochemical output accounts for about 45 percent of the total chemical output. Its ethylene capacity has been around 4.5 million tonnes, ranking on the top ten nations in the world.

#### REIMBURSEMENT OF AIRFARE:

- Export turnover of the participating company in the immediate preceding year should not be more than Rs 30 Crores. In case the turnover is more than 30 crores then members will not get the reimbursement of airfare.
- The Ministry of Commerce & Industry (MoC&I) has "in principle" approved the reimbursement of Airfare to the Member-Exporters participating in this delegation. The reimbursement will be done as per the terms and conditions laid down by the MoC&I under old MDA Scheme and after receipt of funds from the ministry.
- The participating company should submit export returns to the Council regularly.



# The reimbursement of Airfare will be made after finalization of accounts in Ministry and subject to receipt of funds from the Govt. of India.
