CHEMEXCIL Export Award 2021-22 & 2022-23

New Criteria Proposal Dated 18.02.2025 / Revised 20.05.2025

- **To link the export awards with MSME Criteria:** The MSME revised criteria, linked with Investment and Turnover, came into effect from 1st July, 2020. Hence the F.Y. 2021-22 was the first full F.Y. falling under new MSME Criteria. These leads CHEMEXCIL to adopt Export Awards linkage with MSME Criteria from F.Y. 2021-22 onwards.
- As per the new MSME criteria, the status of any enterprise, for F.Y. 2021-22 & 2022-23, is defined as:
Micro Enterprise – Turnover does not exceed Rs. 5 Crores
Small Enterprise – Turnover does not exceed Rs. 50 Crores
Medium Enterprise – Turnover does not exceed Rs. 250 Crores
Large Enterprise – Turnover more than Rs. 250 Crores
- Now CHEMEXCIL Export Awards are being linked to MSME Criteria, where the eligibility can be finalised as:


Award For MANUFACTURER EXPORTER under category of Micro Enterprise (3 awards each for 4 Panels of CHEMEXCIL):

- The applicant shall fall under Micro Category, where their TOTAL Turnover shall NOT Exceed Rs. 5 Crores. Amongst all Micro Applicants,
- The applicant must have **minimum FOB Value Exports of Rs. 1 Crore**, in the year of application.
- the **HIGHEST** FOB Value of Export will be considered for **GOLD** Award.
- the **SECOND HIGHEST** FOB Value of Export will be considered for **SILVER** Award
- the **THIRD HIGHEST** FOB Value of Export will be considered for **BRONZE** Award.

Award For MANUFACTURER EXPORTER under category of Small Enterprise (3 awards each for 4 Panels of CHEMEXCIL):

- The applicant shall fall under Small Category, where their TOTAL Turnover shall NOT Exceed Rs. 50 Crores, but above Rs. 5 Crores. Amongst all Small Applicants,
- The applicant must have **minimum FOB Value Exports of Rs. 10 Crores**, in the year of application.
- the **HIGHEST** FOB Value of Export will be considered for **GOLD** Award.
- the **SECOND HIGHEST** FOB Value of Export will be considered for **SILVER** Award
- the **THIRD HIGHEST** FOB Value of Export will be considered for **BRONZE** Award.

Award For MANUFACTURER EXPORTER under category of Medium Enterprise (3 awards each for 4 Panels of CHEMEXCIL):



- The applicant shall fall under Medium Category, where their TOTAL Turnover shall NOT Exceed Rs. 250 Crores, but above Rs. 50 Crores. Amongst all Medium Applicants,
- The applicant must have **minimum FOB Value Exports of Rs. 50 Crores**, in the year of application.
- the HIGHEST FOB Value of Export will be considered for GOLD Award.
- the SECOND HIGHEST FOB Value of Export will be considered for SILVER Award
- the THIRD HIGHEST FOB Value of Export will be considered for BRONZE Award.

Award For MANUFACTURER EXPORTER under category of Large Enterprise (3 awards each for 4 Panels of CHEMEXCIL):

- The applicant shall fall under Large Category, where their TOTAL Turnover shall be ABOVE Rs. 250 Crores. Amongst all Large Applicants,
- The applicant must have **minimum FOB Value Exports of 20% of the total Sales**, in the year of application.
- the HIGHEST FOB Value of Export will be considered for GOLD Award.
- the SECOND HIGHEST FOB Value of Export will be considered for SILVER Award
- the THIRD HIGHEST FOB Value of Export will be considered for BRONZE Award.

Awards for MERCHANT EXPORTERS (3 awards):

- The applicant shall register as ONLY MERCHANT EXPORTER with CHEMEXCIL. If any member is having dual registration with CHEMEXCIL like Merchant & Manufacturer, then they shall apply for Manufacturer Categories and they shall not eligible for Merchant Category Awards.
- The applicant must have **minimum FOB Value Exports of 20% of the total Sales**, in the year of application.
- the HIGHEST FOB Value of Export will be considered for GOLD Award.
- the SECOND HIGHEST FOB Value of Export will be considered for SILVER Award
- the THIRD HIGHEST FOB Value of Export will be considered for BRONZE Award.

➤ **This will lead to Maximum 51 Export Awards per F.Y. amongst 5 panels of CHEMEXCIL.**

(4-Catergory, 4-Panels, 3 Award types, =48 + 3 Merchant Export award Total 51)

➤ **General Rules for Applicants:**

- The Manufacturer Exporter award applicant needs to submit UDYAM Registration Certificate with mention of their Category of application (Micro / Small / Medium) and for the year of application. (Here the UDYAM certificate of any later F.Y., but which mentions the status of Award Application Year in the certificate, will be considered)
- For the Manufacturer Exporter award applicant, falling under Large Enterprise and who does not have UDYAM Registration, the Total Turnover of ABOVE Rs. 250 Crores, will have to be justified by CA Certified Figures.



- The FOB Value of Export means & only restricted to the HS Codes, under the purview of CHEMEXCIL. Exports under other HS Codes will NOT be considered for award category. The figures will have to be justified by CA Certified Figures.
- The FOB Value of Exports for products under purview of CHEMEXCIL and the Total Turnover for the F.Y. of application and previous F.Y. will have to be certified by their Auditors / CA, as per the attached format in **Annexure 1**.
- **The applicant MUST Have 5% Growth in FOB Exports for the FY of application as compared to Previous FY.**
- If an applicant has claimed under any category but their status in earlier FY was falling under different category, then the application shall be allowed but they need to have 5% growth in FOB Exports.
- A Company should be paid member of the council for the **last 3 financial years** with valid membership and RCMC, from the last 3-years of award application. (e.g., *If an exporter is applying for export award for FY 2021-22, then the company should be member of council from FY 2019-20*)
- Company should not be in DEL Category of DGFT, while applying for export award.

➤ **TRISHUL Award:**

- With an intention to give a Special Recognition, it is proposed to give an extraordinary weightage to TRISHUL Awards.
- **Trishul Award can replace ONLY Gold Award**, in any panel of CHEMEXCIL.
- Trishul Award shall be awarded to an applicant having FOB Exports of Rs. 75 Crores or higher and they are eligible for GOLD Award in their respective Panel but the Growth shall be 10% as compared to previous FY and again 10% growth in previous FY as compared to previous but one FY.
- Thus 2 years consecutive 10% growth of FOB Exports, will be awarded with Trishul Award.
- To claim Trishul Award, the applicant needs to submit CA Certificate as **Annexure 2** and **not Annexure 1**.
- **IMP. NOTE: IT IS ADVISED THAT IF AN APPLICANT IS HAVING CONSECUTIVE GROWTH OF 10% IN 2-FINANCIAL YEARS THEY SHOULD APPLY WITH ANNEX-II SO THAT THEIR ELIGIBILITY FOR TRISHUL AWARD CAN BE ACCEPTED.**
