#### VOTING

- a) The voting will be done through electronic voting process only.
- b) Electronic voting is open only to Ordinary Members. The voter list in the said regard is displayed on website [http://dgft.gov.in/dgftmumbai/html/chemexcil/election\\_coa.htm](http://dgft.gov.in/dgftmumbai/html/chemexcil/election_coa.htm) as updated on 19-January-2016.
- c) The Ordinary Members shall have the right to vote for the posts as specified.
- d) Only the authorized representative, whose name is mentioned as such in the membership application while applying for membership with the Council, shall have the right to vote at the Election.

- e) Each Ordinary Member of the Council shall have one vote for the respective panel as opted at the time of registration of membership.

#### PROCEDURE FOR ONLINE ELECTRONIC VOTING

- a) The online electronic voting will commence from 10.30 am on 24<sup>th</sup> Feb 2016 and continue till 5.00 pm on 29<sup>th</sup> Feb 2016.
- b) Each Voter Member shall follow the procedure of Electronic Voting as specified in the Annexure to this Notice to cast his/ her vote.
- c) In addition to the above, Voter members may like to note the following
- An e-mail to the individual eligible voter members for confirming the E-mail ID and Mobile number which are required for the casting of online electronic vote had been sent. The last date for receipt of such requests was 19<sup>th</sup> January, 5:00 PM. The requests received till the cut-off date only have been processed.
  - The data in the said regard has been frozen on 19-Jan-2016 and no change can be made now as the electronic voting process will commence on 24<sup>th</sup> Feb 2016.
  - The time line / deadlines for the voting process will be strictly adhered to and no request will be entertained for extension of the same due to any reason whatsoever.
