NOTICE TO ALL COMMITTEE OF ADMINISTRATION MEMBERS (AS PER THE VOTERS LIST OF FY 2015-16) OF DYES & DYE INTERMEDIATES, BASIC ORGANIC & INORGANIC CHEMICALS INCLUDING AGRO CHEMICALS, COSMETICS & TOILETRIES, CASTOR OIL AND SPECIALITY CHEMICALS AND MERCHANT EXPORTER PANELS WHO HAVE RENEWED THEIR MEMBERSHIP FOR THE FINANCIAL YEAR 2015-16 ON OR BEFORE 30TH JUNE, 2015.

Re.: Nomination for Election of Vice-Chairman of Basic Chemicals, Cosmetics & Dyes Export Promotion Council.

Dear Members,

As per Para 2.92 of the Handbook of Procedures of FTP 2015-2020, followed by the Meeting of the Committee of Administration held on 09th March, 2016, it has been decided to conduct re-election for Vice Chairman of the Council. Accordingly, the re-election of Vice Chairman would now be conducted for the period 2015-17 and for such purpose, the voter list for Financial Year 2015-16 shall be utilized.

Since Vice-Chairman was elected prior to coming into force of <u>FTP 2015-2020</u>, for fresh elections, through e-voting as mandated in the advisory letter No. 12/2/2013-E&MDA dated 7^{th} Dec., 2015 and subsequently clarification letter No. 14/19/2015-E&MDA dated 7^{th} March, 2016 received from Ministry of Commerce and Industry, New Delhi, the provisions of Para (viii) of the advisory dated 7-12-2015 is applicable prospectively.

2. ELIGIBILITY FOR ELECTIONS

Any elected member of the Committee of Administration is eligible to contest the election for Vice Chairman.

2.1 Voters list

The final updated voters list has been displayed on DGFT, Mumbai's website http://dgft.gov.in/dgftmumbai/html/chemexcil/election_coa.htm and CHEMEXCIL's website https://chemexcil.in.

2.2. Eligibility to Vote

(a) Ordinary Members shall have the right to vote at the Election of Vice Chairman of Council as per para 2.92 of <u>FTP 2015-2020</u>.

(b) Each Ordinary Member of the Council shall have one vote for election of Vice

Chairman.

2.3 Eligibility for Candidature for Vice Chairman

(a) He/ She must be elected Committee Member and Ordinary Member of the Council;

(b) He / She or the entity represented by him, must have to his or its credit during the one financial year immediately preceding, exports of the product falling under purview of Council not less than Rupees 2 crores.

(c) Candidate applying for nomination for election should submit Bank Certificate of realization in support of his/her fulfillment of condition under Para 4.2 (b) of the bye

laws of the Council.

(d) Any voter / member under Denied Entity List maintained by DGFT will not be eligible to file nominations for election of Vice Chairman. Therefore, on the original Nomination form itself the Member organization will also have to submit a declaration in writing signed by the Chairperson / Managing Director / Director / Partner / Proprietor as the case may be that the name of the firm / company is not under Denied Entity List.

3. PROCEDURE FOR FILING & DEADLINE FOR SUBMISSION & WITHDRAWAL OF NOMINATION ETC.

- (i) A Nomination Form to be valid, must be:
 - (a) Original Nomination Form enclosed with this Notice
 - (b) Duly filled-in Nominations complete in all respects, along with the necessary declarations, duly singed, stamped and complying with the Byelaws/Rules mentioned in this notice. The forms and notice will also be available on the DGFT, Mumbai's website.
 - (c) http://dgft.gov.in/dgftmumbai/html/chemexcil/election_coa.htm and CHEMEXCIL's website https://chemexcil.in.
 - (d) The sealed cover containing i) filled in prescribed forms for the Vice Chairman duly signed by the Proposer and Nominee and also ii) Turnover of Company duly certified by chartered Accountant and iii) sealed enveloped duly superscripted on the top as "NOMINATION FOR ELECTION OF VICE CHAIRMAN" may be sent to undersigned by hand-delivery or by Registered Post or by Speed Post addressed to Mr. A.K. Jha, Jt. Director General of Foreign Trade & Election Authority for

CHEMEXCIL, Nishtha Bhavan, 48, Vithaldas Thackersey Marg, Churchgate, Mumbai 400 020 so as to reach on or before 4th **April, 2016** by 3.00 p.m. Nomination received after the due date and time shall not be considered. Those nominations which are not in accordance with this notice / specimen nomination form shall be treated as invalid.

- (e) A Nomination sent by telex/fax/telegram/e-mail to the Election Authority will be treated as invalid.
- (f) Any Nomination forms submitted to any of the offices of CHEMEXCIL will not be considered for scrutiny and will be treated as invalid.
- (ii) The firm / company represented by the proposer & the Nominee should be member of the Council. Names of Companies of both the Nominee and the Proposer should not appear in **Denied Entity List of Directorate General of Foreign Trade** (Refer format given in Annexure A-2).
- (iii) In the event of the Election Authority having reasons to doubt the veracity of any of the particular/information contained in any Nomination form received by it, the Election Authority may call particulars/information from the Executive Director of the Council. He / She will also be at liberty to call for export performance of the member concerned as per the record of the Council from the Executive Director.
- (iv) The names of the nominees panel-wise shall be entered in a register and after due scrutiny a list of valid nominations received will be prepared. Copies of such lists duly signed by the undersigned shall be sent to Head Office and all the Regional Offices of the Council. The same will be available on the website of DGFT, Mumbai and CHEMEXCIL's website. In case of the invalid nominations the undersigned shall cite the reason for rejecting the same.
- (v) Nomination can be withdrawn by the candidate by a letter signed by him / her after aforesaid display of the list of valid nominations by the Election Authority. Original letter of withdrawal of nominations need to be submitted to the undersigned at Mumbai. Withdrawal of nomination will be allowed on or before 7th April 2016 by 3.00 p.m.
- (vi) Such a withdrawal shall be final and no subsequent request, for revoking such withdrawal shall be entertained by the undersigned.
 - (g) As per the directives received from Ministry of Commerce & Industry, Government of India, on 07th December, 2015, it has been decided to conduct elections for Vice Chairman of the Council by online electronic voting process; the user manual for the same will be available on DGFT, Mumbai's website http://dgft.gov.in/dgftmumbai/html/chemexcil/election coa.htm and CHEMEXCIL's website https://chemexcil.in.
- (vii) For participating in the online electronic voting process a valid E-mail ID and mobile number of the authorized representative is mandatory. (Please check the voters list uploaded on DGFT, Mumbai website as well as CHEMEXCIL website for the e-mail id available as per the records.)

- (viii) In case of any mistakes / errors in the <u>e-mail IDs</u> mentioned in the voters list displayed on DGFT, Mumbai website as well as CHEMEXCIL website, please inform this office in writing on or before 7th April, 2016 by 3.00 p.m. at <u>electionepc@gmail.com</u> with a copy endorsed to <u>election@chemexcil.gov.in</u>.
- (ix) No further communication will be entertained after 7th April, 2016 in this regard for any modifications / changes / updation in the records and therefore, details given as per the records of the Election Authority, will be treated as final and correct.

Members may note that the said nomination notice and the forms are being printed and dispatched in hard copy by Post for their convenience. However, Election Authority will not be responsible for the late receipt due to postal delay.
