<u>Sub: Election for the post of Vice Chairman Basic Chemicals. Cosmetics & Dyes</u> <u>Export Promotion Council – Call for Nomination.</u>

Dear Members,

As per para 2.9 of the Handbook of Procedures of <u>FTP 2015-20</u> and Amended Bye Laws of the Council followed by the 1st meeting of the Committee of Administration for the year 2021-22 held on 25th June, 2021 it has been decided to conduct election of Vice- Chairman of the Council. Accordingly, the election for the post of Vice Chairman shall be conducted for the period 2021-23.

2. ELIGIBILITY FOR ELECTIONS:

Any elected member of the Committee of Administration is eligible to contest the election for the post of Vice Chairman. However, as per Article 9.3 of Amended Bye Laws of the Council, any member having held the post of Chairman or Vice-Chairman may come back as Vice Chairman in the Council after a gap of not less than 4 years.

2.1 <u>Right to Vote and Contest etc. confined to ordinary members</u>

The final updated voter list has been displayed on DGFT, Mumbai's website: <u>http://dgftcom.nic.in/dgftmumbai</u> and CHEMEXCIL's website <u>https://chemexcil.in</u>

2.2 Eligibility to Vote

- a) The Ordinary Members shall have right to vote at the Election for the post of Vice Chairman as per Article 35 of the Amended Bye Laws of the Council and para 2.92 of <u>FTP 2015-20</u>.
- b) Each Ordinary Member of the Council shall have one vote for every single representation registered with the Council from time to time.

2.3 Eligibility for Candidature for Vice- Chairman

- a) He /She must be elected committee Members and ordinary Members of the Council;
- b) Person standing for election, his/her name should appear in either RCMC or Import Export Code.
- c) He/She or the entity represented by him/her, must have to his or her credit during one financial year immediately preceding, export of products falling under purview of the Council of not less than Rupees 2 crores.
- d) Candidate applying for nomination for election should submit Bank Certificate of Realization or Certificate from Auditor of the company who signs the balance sheet in support of their fulfilment of condition under Para 4.2 (a) wherein products & FOB value of exports are given.
- e) Any voter / member under Denied Entity List maintained by DGFT will not be eligible to file nominations for election of Vice Chairman. Therefore, on the original Nomination form itself the Member organization will also have to submit a declaration in writing signed by the chairperson / Managing Director / Director Partner/Proprietor as the case may be that the name of the firm /company is not under Denied Entity List.

3. <u>PROCEDURE FOR FILING & DEADLINE FOR SUBMISSION & WITHDRAWAL OF</u> <u>NOMINATION ETC.</u>

Only CoA members shall have right to contest the election and propose the nominee for the post of Vice Chairman.

- i) A Nomination Form to be valid, must be-
 - (a) The original Nomination Form enclosed with this Notice
 - (b) Duly filled up in all respects, along with the necessary declarations, duly singed, stamped and complying with the provisions of Election Rules herein before and as mentioned in this notice. The form and notice will also be available on the DGFT. Mumbai's websitehttp://dgftcom.nic.in/dgftmumbai and CHEMEXCIL's website https://chemexcil.in
 - (c) The sealed cover containing i) filled in prescribed forms for the vice chairman duly singed by the Proposer and Nominee and also li) Turnover of company duly certified by chartered Accountant and iii) sealed enveloped duly superscripted on the top as "NOMINATION FOR ELECTION OF VICE CHAIRMAN" may be sent to undersigned by handdelivery or by Registered post or by speed post addressed to Shri M.K. Nikhare, Joint Director General of Foreign Trade & Election Authority of CHEMEXCIL, Nishtha Bhavan, 48 Vithaldas Thackersey Marg, Churchgate, Mumbai 400 020 so as to reach on or before 7th September, 2021 by 3.00 pm.

- (d) Nomination received after the due date and time shall not be considered. Those nominations which are not in accordance with this notice/specimen nomination form shall be treated as invalid.
- (e) A Nomination sent by telex/fax/telegram/e-mail to the Election Authority will be treated as invalid.
- (f) Any Nomination forms submitted to any of the offices of CHEMEXCIL will not be considered for scrutiny and will be treated as invalid.
- ii) The firm / company represented by the proposer & the Nominee should be member of the Council. Names of Companies of both the Nominee and the Proposer should not appear in **Denied Entity List of Directorate General** of Foreign Trade (Refer format given in Annexure A-2).
- iii) In the event of the Election Authority having reasons to doubt the veracity of any of the particular/information contained in any Nomination form received by it, the Election Authority may call particular / information from the Executive Director of the Council. He / She will also be at liberty to call for export performance of the member concerned as per the record of the Council from the Executive Director.
- iv) The names of the nominee's panel-wise shall be entered in a register and after due scrutiny a list of valid nominations received will be prepared. Copies of such lists duly signed by the undersigned shall be sent to Head Office. The same will be available on the website of DGFT, Mumbai and CHEMEXCIL's website. In case of the invalid nominations the undersigned shall cite the reason for rejecting the same.
- v) Nomination can be withdrawn by the candidate by a letter signed by him / her after aforesaid display of the list of valid nominations by the Election Authority. Original letter of withdrawal of nominations need to be submitted to the undersigned at Mumbai. Withdrawal of nomination will be allowed on or before 14th September, 2021 by 3.00 p.m.
- vi) Such a withdrawal shall be final and no subsequent request, for revoking such withdrawal shall be entered by the undersigned.
- vii) For participating in the online electronic voting process a valid E-mail ID and mobile number of the authorized representative is mandatory. Please check the voters list uploaded on DGFT, Mumbai website as well as CHEMEXCIL website for the e-mail id available in record with us.

Members may note that the said nomination notice and the forms are being printed and dispatched in hard copy by Post for their convenience. However, Election Authority will not be responsible for the late receipt due to postal delay. Members are advised to use the

- 1. A candidate contesting election as Vice Chairman in the Council must satisfy the following conditions, namely:
 - a. He/She or the entity represented by him, must have to its credit during the one financial year immediately preceding exports of the products falling under purview of Council of not less than Rupees 2 crores.

Candidate should represent the industry coming under the purview of the Council.

- b. Candidate applying for nomination for election should submit Bank Certificate of Realization or Certificate from Auditor of the company who signs the balance sheet in support of their fulfilment of condition under Para 4.2 (a) wherein products & FOB value of exports are given.
- c. He/ She should predominantly exporter of the items coming under the purview of the Council.
- 2. Please enclose original certificate duly signed by Chartered Accountant certifying export performance in Indian Rupees (rounded off to nearest Lakh). (Format of CA certificate is given in Annexure A-1)
- 3. The Director / Partner / Proprietor, as the case may be of the Company /Firm should furnish an undertaking along with Nomination form, that the Company / Firm is not listed under DEL maintained by the Directorate General of Foreign Trade, Govt. of India as per existing Foreign Trade Policy (Format of undertaking is given in Annexure A-2).
- 4. Only CoA members shall have right to contest the election for the post of Vice Chairman.
