The Directorate-General for Trade of the European Commission presents its compliments to the Mission of India to the European Union and has the honour to notify it that the European Commission has received a properly documented complaint requesting the initiation of an anti-dumping proceeding concerning imports of **Barium Carbonate** originating in India.

Should the European Commission decide to initiate an anti-dumping proceeding, information, including copies of the notice of initiation, the complaint, and a link to the questionnaires will be provided to the Mission of India to the European Union immediately upon publication of the notice of initiation of the anti-dumping proceeding in the *Official Journal of the European Union*.

The Directorate-General for Trade of the European Commission wishes to bring to the attention of the Mission of India to the European Union that should the proceeding be initiated, in view of the potentially large number of exporting producers in India involved and in order to complete the investigation within the statutory time-limits, the Commission may limit the exporting producers that will be investigated to a reasonable number by selecting a sample.

In such a case, the Commission's services would appreciate the cooperation of the Mission of India to the European Union in the selection of a representative sample of exporting producers.

In addition, please find attached a list of exporting producers that have been identified in the complaint. The Mission of India to the European Union is urgently requested to check this list for accuracy and completeness and to provide the Commission with the names, addresses, contact persons, and email addresses of any other exporting producers that may be concerned but are not listed in the complaint no later than 18 December 2024.

This is to ensure that, should the European Commission decide to initiate an anti-dumping proceeding, it can contact them without delay. The Commission appreciates the collaboration of the Mission of India to the European Union in ensuring that all exporting producers have full opportunity to cooperate in the investigation.
