Chairman's Desk

I am pleased to address you once again through this edition of our Bulletin. The months of August and September 2025 have been particularly eventful for the chemical export sector, witnessing a series of significant global and domestic policy developments that are shaping the evolving trade environment. As our industry continues to work diligently to consolidate and accelerate export growth, it is essential to take stock of these developments, thoroughly assess their implications, and strategically chart a course forward that safeguards and advances our interests.

At the heart of our efforts lies the clear and ambitious vision of CHEMEXCIL: to position India as a global leader in the chemical sector by fostering innovation, ensuring sustainable practices, and empowering our exporters to confidently and competitively access every significant market worldwide. This vision reflects our commitment to not only expanding the volume of exports but also enhancing quality, sustainability, and value addition throughout the chemical value chain.

On 25th September 2025, we convened the 62nd Annual General Meeting of CHEMEXCIL, which proved to be a pivotal event for our community. This gathering offered members a valuable platform to critically review the Council's initiatives, share insights on the various challenges facing the sector, and collaboratively outline strategic priorities for the coming years. The discussions reaffirmed our collective dedication to strengthening



India's chemical export competitiveness and underscored the collaborative spirit required to navigate complex global markets.

One of the major global developments capturing the attention of exporters is the recent policy announcement by the United States regarding the review and revision of tariffs on a broad range of imported products, including select categories of chemicals. Given that the US remains one of the largest and most important markets for Indian chemical exports, any changes in tariff structures can directly impact our market competitiveness, pricing strategies, and overall export performance.

While certain chemical product lines may experience increased duties, potentially raising costs for exporters, other categories might benefit from tariff reductions or realignments, creating new opportunities for market penetration and growth. In response, CHEMEXCIL has proactively initiated a comprehensive and detailed analysis of the revised US tariff schedule to clearly identify specific product segments likely to be affected. We are actively engaging with industry stakeholders, trade experts, and relevant government departments to prepare timely and well-substantiated representations that protect and promote India's interests in this critical market.

Members are strongly advised to maintain close vigilance over buyer communications from the US, align their supply contracts with the newly introduced duty frameworks, and explore alternate trade arrangements or diversified market strategies to mitigate potential risks arising from tariff changes. To further support exporters, the Council will shortly organize an interactive session involving trade experts and legal advisors aimed at providing practical guidance on navigating the complexities of the new US tariff regime effectively.

In parallel, negotiations on the India–UK Free Trade Agreement (FTA) have progressed to an advanced stage, reflecting positive and encouraging signals from both governments. The chemical sector remains a key focus of these discussions, particularly concerning tariff concessions, mutual recognition of standards, and enhanced market access. The UK market holds strategic importance for Indian chemical exporters, not only for its standalone value but also as a gateway to the wider European region, amplifying the potential benefits of a well-structured FTA.

If finalized on favourable terms, the India–UK FTA could serve as a catalyst for substantive growth in exports of dyes, pigments, specialty chemicals, and other critical product categories within CHEMEXCIL's ambit. Throughout this process, CHEMEXCIL has maintained continuous consultation with the Ministry of Commerce and Industry, offering detailed inputs on product-specific tariff lines, rules of origin clauses, and addressing regulatory concerns raised by members. We have also advocated strongly for recognition of Indian quality standards, simplification of customs and clearance procedures, and tackling non-tariff barriers that currently impede seamless market access.

I urge all members to actively share detailed feedback with the Council regarding any difficulties or challenges faced in exporting to the UK. Your inputs will be invaluable in shaping our ongoing representations aimed at securing a comprehensive FTA that addresses both tariff and non-tariff barriers—an outcome that promises to be a gamechanger for the chemical export industry.

Domestically, the industry continues to engage with evolving GST regulations, which remain a significant topic of discussion. CHEMEXCIL has welcomed recent government decisions on GST rationalization, recognizing their potential to encourage domestic production, strengthen profit margins, and reinforce India's ambition to emerge as a global chemical hub. These changes align strategically with national initiatives such as Atmanirbhar Bharat and Make in India, further supporting self-reliance and sustainable industrial growth.

In an era of rapidly evolving global trade dynamics, adaptability and proactiveness are critical for sustained success. CHEMEXCIL remains steadfast in its commitment to supporting members through various initiatives. Over the past two months, we have organized numerous seminars and webinars focused on trade compliance, regulatory updates, and facilitated meaningful dialogue with policymakers to ensure members are well-equipped to tackle emerging challenges.

We strongly encourage all members to actively participate in these initiatives and take full advantage of the networking, knowledge-sharing, and business expansion platforms that CHEMEXCIL offers. Such engagement not only enriches individual businesses but strengthens the entire industry ecosystem.

Director General's Desk

Dear Members.

Warm greetings to all of you. As we step into the second half of this financial year, it is an opportune moment to review recent developments in global trade, domestic policy changes, and outline our upcoming promotional initiatives.

The chemical export sector continues to be a vital pillar of India's external trade, and CHEMEXCIL remains dedicated to supporting its members through effective policy advocacy and active promotion in international markets.

The 62nd Annual General Meeting of CHEMEXCIL was successfully held on 25th September 2025. This important event provided a platform for members to review the Council's activities over the past year, discuss sector challenges, and collaboratively set strategic priorities for the future. The meeting highlighted our united commitment to strengthening India's chemical export competitiveness and exploring new growth avenues.

The United States has recently announced revisions to its tariff schedules that cover a broad range of products, including select chemicals. Given that the US remains a predominant destination for Indian chemical exports, this development holds immediate importance for our members.

While some chemical segments may face increased duties, opportunities could also arise in categories where tariff adjustments favor Indian exporters, thereby enabling diversification away from other suppliers.

We are closely coordinating with the Ministry of Commerce & Industry to ensure India's concerns are communicated effectively at appropriate forums. Meanwhile, exporters are advised to carefully review their current contracts with US buyers and consider hedging strategies along with exploring alternate market linkages to reduce risks associated with tariff changes.

Negotiations between India and the United Kingdom for a Free Trade Agreement (FTA) are progressing positively. The chemical sector has been identified as a key focus area in these discussions. Among the priorities raised by CHEMEXCIL on behalf of members are reduction of tariff barriers, recognition of Indian testing and certification standards, and resolution of non-tariff barriers.

The expected conclusion of the FTA promises to expand market access for Indian dyes, pigments, and specialty chemicals. The Council is working in close collaboration with the Ministry to ensure that the unique concerns of our members are addressed. We invite exporters to share detailed feedback on product-specific challenges that can be raised during consultations.

On the domestic front, GST compliance remains an important concern for exporters. While progress has been made in digitization and automation, challenges persist in areas such as refund delays, disputes over HSN classification, and reconciliation of input tax credits.



The coming months will be critical as our industry manages global trade uncertainties while seizing opportunities presented by FTAs and overseas market promotion. CHEMEXCIL will continue to represent members' concerns at all relevant policy forums while simultaneously working to open new avenues through trade promotion activities.

Alongside policy advocacy, CHEMEXCIL actively promotes Indian chemical exports by participating in international exhibitions and trade fairs. These platforms offer unparalleled opportunities for members to showcase their products, engage with global buyers, and strengthen their presence in emerging markets.

A flagship initiative this year is the India Pavilion at KHIMIA 2025, to be held in Moscow, Russia. KHIMIA is a premier international trade fair for the chemical industry, drawing buyers, distributors, and stakeholders from across the CIS region and beyond. The India Pavilion, organized by CHEMEXCIL, will showcase the strengths of the Indian chemical industry and serve as a unified platform for member exporters to connect with international visitors.

In addition, CHEMEXCIL has been organizing an informative series of webinars to equip members with essential knowledge and tools to navigate the evolving trade environment. These sessions include topics such as:

- Webinar on India-UK (CETA) Free Trade Agreement exploring emerging opportunities for the chemical sector under this agreement.
- Authorized Economic Operator (AEO) Certification Process, Compliance & Benefits guiding exporters through the certification procedure to enhance supply chain security and gain trade facilitation benefits.
- Trade Credit Insurance and the Role of Export Credit Guarantee Corporation (ECGC) outlining mechanisms to safeguard exporters against payment risks.
- PFAS Forever Chemicals: A Global Regulatory Overview providing an update on international regulatory developments affecting production and export of PFAS-related chemicals.
- Understanding FEMA Regulatory Guidelines for Exporters covering essential foreign exchange management compliances for smooth export operations.
- Trade Connect ePlatform with DGFT introducing this digital platform for streamlined trade facilitation.
- Sensitization-cum-Onboarding Camp on ChemIndia Portal assisting members in utilizing the Council's digital portal for enhanced service delivery.

RODTEP - Good News plus Homework

On 1st October 2025, an order has been passed by CBIC for constitution of RODTEP Committee 2025 in order to review RODTEP rates under the Chairmanship of Nirajkumar Gupta Secretary retired Government of India.

Quote

- 1. The Terms of Reference of the Committee shall be as follows:
 - a) To interact with the administrative Ministries, Export Promotion Councils, Commodity Boards, Trade Bodies and other stakeholders to elicit their views on the ROSCTL & RODTEP rates for exports by Domestic Tariff Area (DTA,) Export Oriented Units (i.e. EOU) and Special Economic Zones (i.e. SEZ) units and exports under Advance Authorization (i.e. AA) scheme;
 - b) To work out the modalities for calculation of duties/ taxes/ levies at the Central, State and Local level, borne on the exported product, including prior stage cumulative indirect taxes on goods and services used in the production of exported product and such indirect duties/ taxes/ levies in respect of distribution of exported product and recommend in their report the ceiling rates under RoSCTL and RoDTEP schemes for DTA, AA, EOU and SEZ exports. The Committee may take into consideration the incidence of such duties/ taxes/levies on DTA, AA, EOU and SEZ exports and other relevant factors as deemed fit;
 - To give supplementary report/ recommendations on issues or representation, if any, arising after notification of the revised

- rates consequent to the report of the Committee.
- d) To examine whether any further modifications are needed in the existing rates/caps for items covered under the RODTEP, ROSCTL schemes and the Drawback Schedule which have undergone change, either in description or Customs Tariff heading, consequent to the changes brought about in the Customs Tariff Schedule with effect from 01.05.2025.
- 2. For discharging the above Terms of Reference, the Committee will
 - a) Determine the methodology;
 - b) Decide the modalities of holding deliberations and meetings with the stake holders;
 - c) Conduct field visits and study specific production processes as it may consider necessary:
 - d) suggested ceiling rates as part of its report Provide documentation and calculation or worksheets, supporting the
- 3. **Supplementary report**, if required may beain report to the six weeks of notification of the The Committee will submit its main report to the Government by 31.03.2026. A revised rates under the RODTEP and ROSCTL schemes, respectively, keeping in view any post-notification issues.

While this entire exercise is a welcome step, there are still several areas that require **proper explanation and clear directives from the Committee**.

For example, the phrase "such indirect duties/taxes/ levies in respect of distribution of exported product" needs further clarity.

 What exactly is meant by "distribution of exported product"?



- Is this phrase referring to activities related to Free Trade and Warehousing Zones (FTWZ)?
- If yes, does it cover FTWZs located only in India, or those outside India as well?
 Similarly, the concept of "studying specific production processes" also requires elaboration.
- How do different production processes impact remission or non-remission of taxes?
- What kind of studies or assessments have been carried out earlier in this regard?
 - There is also a lack of clarity regarding the different rates applicable for DTA, Advance Authorisation (AA), and EOU units, even though the scheme is meant to neutralize embedded taxes and duties that are otherwise not refunded.
- The RODTEP Scheme itself excludes customs duty and IGST from its purview. So, why are different remission rates being applied across these categories?


Additionally, a number of **procedural questions** remain unanswered.

- Is there any standard procedure or methodology being followed for the major calculations under the scheme?
- Can such a **standardised calculation procedure** be developed and adopted?
- Practical cost elements like return trips, toll charges, and heavy traffic delays also need to be factored in.

The industry must work towards proposing practical, implementable solutions, keeping in mind that RODTEP is a remission scheme, not an incentive or subsidy scheme.

Any **surcharge**, **tax**, **or levy**—whatever its legal nomenclature—if it **contributes to Government revenue directly or indirectly**, must logically be **considered for remission purposes**, and the Government should issue clear guidelines on this point.

If this scheme is to truly serve the **real interests of exporters**, then **serious and coordinated homework is required** from both **industry stakeholders and Government officials**.








Sub: Important Update-Public Consultation on Extension of UK REACH Transitional Registration DeadlinesDear Members.

We wish to inform you that the Department for Environment, Food and Rural Affairs (Defra) - UK Government has launched a **public consultation** on its proposal **to extend the UK REACH** transitional **registration submission deadlines**.



The consultation has opened on 14th July 2025 and will close on 8th September 2025.

As you are aware that under UK REACH, businesses placing chemical substances on the Great Britain (GB) market are required to register relevant information with the UK REACH Agency (Health and Safety Executive – HSE).

Since the BREXIT, the data previously submitted under EU REACH was not transferred to the UK authorities. To address this, the UK has proposed an Alternative Transitional Registration model (ATRm), and is now consulting on revised deadlines to support its implementation.

The UK government prefers Option 1 as it allows sufficient time to finalise ATRm and industry to transition.

The consultation seeks views on extending deadlines for HSE's compliance checks on 20% of registration dossiers, as required under Article 41(5) of UK REACH.

Chemical manufacturers and importers in UK are encouraged to submit their views and feedback to the UK REACH Policy & Legislation, Consultation Team. The last date to submit the inputs / views is 8th September 2025.

After the consultation, a summary of the responses to this consultation will be published and placed on the government website at www.gov.uk/defra.

Responses to this consultation will be reviewed and considered in the future policy development of the regulations.

In view of above we request our members to take the note of it. CHEMEXCIL will update on this issue from time to time.

Dear Members,

O/o the Directorate General of Foreign Trade (DGFT) has issued a Notification No. 28/2025-26 dated 28th August 2025 on amendment in Para 2.03(A) (i) (g) of the FTP 2023 laying down enabling provisions for import of inputs that are subjected to mandatory quality control orders (QCOs), by Advance Authorisation holders, EOU and SEZ.

Earlier, for chemical and petrochemical products notified by the Department of Chemicals & Petrochemicals (DCPC), the Export Obligation (EO) period was restricted to 180 days (6 months).

The New Provision (after amendment) is EO period for such imports as per Para 4.40 of the Handbook of Procedures is 18 months. DGFT has removed an important compliance barrier. Exporters now have more time to process imported inputs, manufacture finished goods, and gives exporters much-needed breathing space to stay compliant and competitive.

Sub: ICEGATE advisory on Changes in Filing Ex-Bond Bill of Entry (BoE) from Warehouses: Regarding

Dear Members.

Indian Customs National Trade Portal 2.0 has issued an advisory on changes in the procedure for filing ex-bond Bills of Entry (BoE) from customs-bonded warehouses.

Following are the important changes stated in this advisory.

- Prior to these changes, an Importer-Exporter Code (IEC) holder could file an ex-bond BoE and remove goods from a warehouse, even if the goods were not formally recorded in the system's ledger for that specific IEC and warehouse. The quantity was simply debited from the BoE ledger maintained in the system.
- Now from 1st September 2025, all into-bond BoEs filed on or after this date, goods **can only be ex-bonded if the quantity is available in the system's ledger** and is mapped to both IEC and the specific warehouse where the goods are stored.
- When filing an ex-bond BoE, you must now declare the specific warehouse code.
- Ex-bonding will only be permitted if a ledger exists for your IEC at that declared warehouse.

In view of above members are requested to ensure their warehouse-bonded movement transactions are properly and fully completed on the ICEGATE system before you file for ex-bonding. This will prevent any ledger-related anomalies and ensure a seamless process.

Sub: Important Advisory for CHEMEXCIL Members on Compliance and Visits by Overseas Government Officials under FTAs.

Dear Members,

As you are aware, the Department has signed Free Trade Agreements (FTAs) with many countries and is in the process of signing similar agreements with other countries also.

These FTAs provide preferential access to the markets by reducing tariff barriers resulting in enhancing market access for Indian chemical exporters.

As part of ensuring compliance with FTA rules and maintaining these benefits, overseas government officials such as customs officers and regulatory representatives (of importing countries) generally conducts verification visits to the premises of exporting companies.

The aim of this visit is

- To validate the origin of product.
- Manufacturing processes, and
- · Regulatory compliance of exported goods to respective countries under FTA provisions.

To help our members to prepare for such visits and ensure full compliance, we suggest members to note the following.

- 1. Maintain accurate, complete, and up-to-date documentation records of
- Certificates of Origin,
- Manufacturing records,
- Commercial invoices,
- Packing lists,
- · Material Safety Data Sheets (MSDS),
- Product registration certificate,
- · Any other relevant information, etc.
- 2. Ensure compliance with the importing country's chemical safety, labeling, and regulatory standards.
- 3. Cooperate for transparent and timely access to premises and records during their inspections.



- 4. Train your staff to understand FTA requirements and be ready to respond to the queries asked by visiting officials during your plant/office visit.
- 5. Keep records of any visits for internal audit for future reference.

Please note any discrepancies, short fall, dissatisfied documents, proofs will lead to denial of preferential tariffs and penalties to the concerned Exporters

We request all members to take a note of this advisory, compliance to protect and support your products trade. (Export and import).

Sub: Extension of RoDTEP Scheme for DTA, AA, SEZ, and EOU Exports up to 31.03.2026

Dear Member.

This is to inform all members that o/O the Directorate General of Foreign Trade (DGFT) has issued Notification No. 35/2025 dated 30th September 2025 regarding the extension of the Remission of Duties and Taxes on Exported Products (RoDTEP) Scheme.

As per the same the validity of the RoDTEP Scheme has been extended beyond 30.09.2025 and will remain applicable for exports made by Domestic Tariff Area (DTA) units, Advance Authorisation (AA) holders, Special Economic Zone (SEZ) units, and Export Oriented Units (EOUs) up to 31.03.2026 (31st March 2026). The existing RoDTEP rates shall continue for all export items. Moreover, the scheme's operation will remain subject to the budgetary framework outlined in Para 4.54 of FTP 2023, ensuring remissions are within the approved allocation for the financial year.

The lists of eligible export items, applicable rates, and per-unit value caps (where applicable) are available on the DGFT website (Appendix 4R for DTA units and Appendix 4RE for AA/SEZ/EOU units) under the Regulations RoDTEP section.
